Record of Decision	<p>That the following strategic priorities for 16-19 (25) Education and Training for 2015/16 be agreed:</p> <p><u>Participation</u></p> <ol style="list-style-type: none"> 1. Increase the number of young people aged 17 participating in education or training and therefore meeting their duty to participate, as required by Raising of the Participation Age; <p><u>Attainment and progression</u></p> <ol style="list-style-type: none"> 2. Reduce the number of young people failing to progress from AS level to A2; 3. Close the gap in attainment at level 2 and level 3 by the age of 19 between young people from deprived backgrounds (those who have been eligible for free school meals) and the overall cohort; 4. Improve progression pathways, including specifically increasing the availability of apprenticeship opportunities at advanced level (level 3) and higher (level 4 and above), to enable young people to access an alternative route to higher level study; <p><u>Curriculum</u></p> <ol style="list-style-type: none"> 5. Maintain a broad curriculum offer across Lincolnshire so that young people are able to access the courses they require to achieve their careers aspirations. This will require schools, colleges and providers to

work together in geographical areas;

6. All young people to have access to independent and impartial careers guidance and information about the labour market and opportunities so that they are able to make realistic, informed decisions about post 14 and post 16 education;

7. Develop programmes and transition pathways which better prepare young people with special educational needs and/or disabilities (SEND) for adulthood and lead to improved outcomes in terms of employment, independent living, good health and community inclusion;

8. Stimulate demand for courses and programmes which better match the economic growth requirements and skills shortages in Lincolnshire, and therefore reduce youth unemployment among 19 - 25 year olds in particular.

Record of Decision	<p>1. That, following planning permissions being granted on 6 October 2014 Lincolnshire County Council make:-</p> <p>(i) a Compulsory Purchase Order under Sections 239, 240, 246, 250 and 260 of the Highways Act 1980 and the Acquisition of Land Act 1981 in the form as set out in Appendices 2A and 2B of the report to secure the compulsory acquisition of the land shown coloured pink on the Order plans at Appendix 2C and the new rights over the land shown coloured blue on the said Order plans on the basis that there is a compelling case in the public interest for making this Order;</p> <p>(ii) a Side Roads Order under Sections 14 and 125 of the Highways Act 1980 in the form set out in Appendix 3A and 3B of the report to carry out works to existing highways and;</p> <p>2. That the Statement of Reasons for the above mentioned Orders as set out in Appendix D of the report be approved.</p> <p>3. That authority be given to the Executive Director for Environment & Economy to make, if necessary, any minor or technical amendments to the Orders referred to in paragraph (1) above or to the Statement of Reasons referred to in paragraph (2) above prior to publication of the Orders.</p>

4. That authority be given to the Chief Legal Officer of Legal Shared Services to seal the Orders and to take all the ancillary or necessary steps, including the publication and service of all statutory notices and presentation of the Council's case at any Public Inquiry, to secure the confirmation of the Orders by the Secretary of State and the vesting of the land in the County Council.

5. That authority be given to the Executive Director for Environment & Economy to request confirmation of the Orders with modifications, if, in the light of new information, it appears expedient to ensure the confirmation of the Orders.

6. That authority be given to the Chief Legal Officer of Legal Shared Services to acquire all third party interests in the land and properties subject to the Compulsory Purchase Order (whether compulsorily or by agreement) on terms recommended by the Executive Director for Environment & Economy.
