



- 6. The deposit shall comprise this Statement, Schedule attached (marked SNR5) and accompanying map.








- Footpath from Kissing Gate at TF 4714 7203 proceeding along the east side of the boundary hedge in a N.N.E. direction for 65m to the north west corner of the grass field and the ownership boundary at TF 4716 7209.
- 88 Footpath from Kissing Gate at TF 4714 7203 proceeding across the grass field in an E direction for 90m to the ownership boundary at TF 4723 7203 before continuing through houses out onto Church Lane.
- 93 Footpath from ownership boundary at TF 4967 7117 proceeding along the east side of the boundary hedge in a N.N.W, direction for 200m to the ownership boundary at TF 4960 7135.
