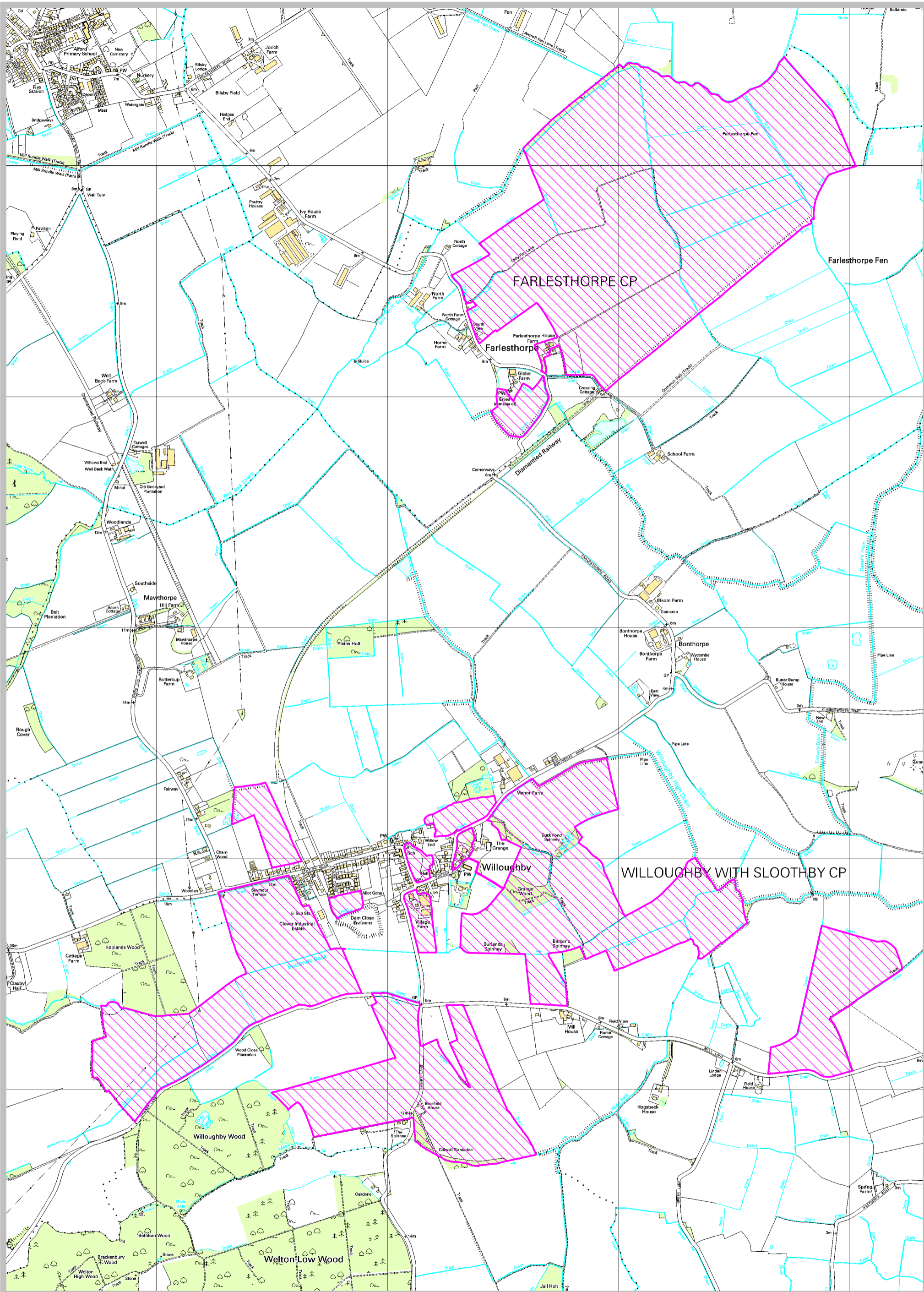

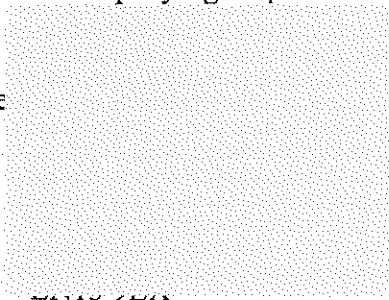

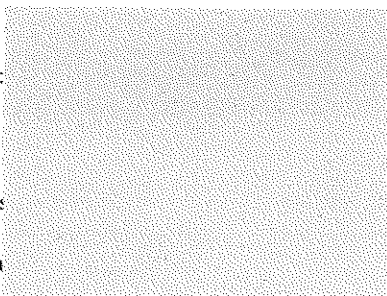

### Willoughby w Sloothby Parish

78 Footpath from footbridge at TF 4633 7163 proceeding in an E. direction across an arable field for approx. 400m to the ownership boundary at the former Clover Dairies Yard at TF 4669 7170.

Re-entering the ownership on the east side of the former Clover Dairies Yard and Dismantled Railway at TF 4677 7173 and proceeding along the north side of the Dam Close grass bank for 140m to the ownership boundary at the south west corner of the allotments at TF 4688 7180.

76 Footpath from Church Lane at TF 4715 7189 proceeding along the west side of the hedge against the Bowling Green and inside land leased for use as a village green in a N.N.W. direction for 40m and then in a N. direction for 90m to Kissing Gate at TF 4714 7203.

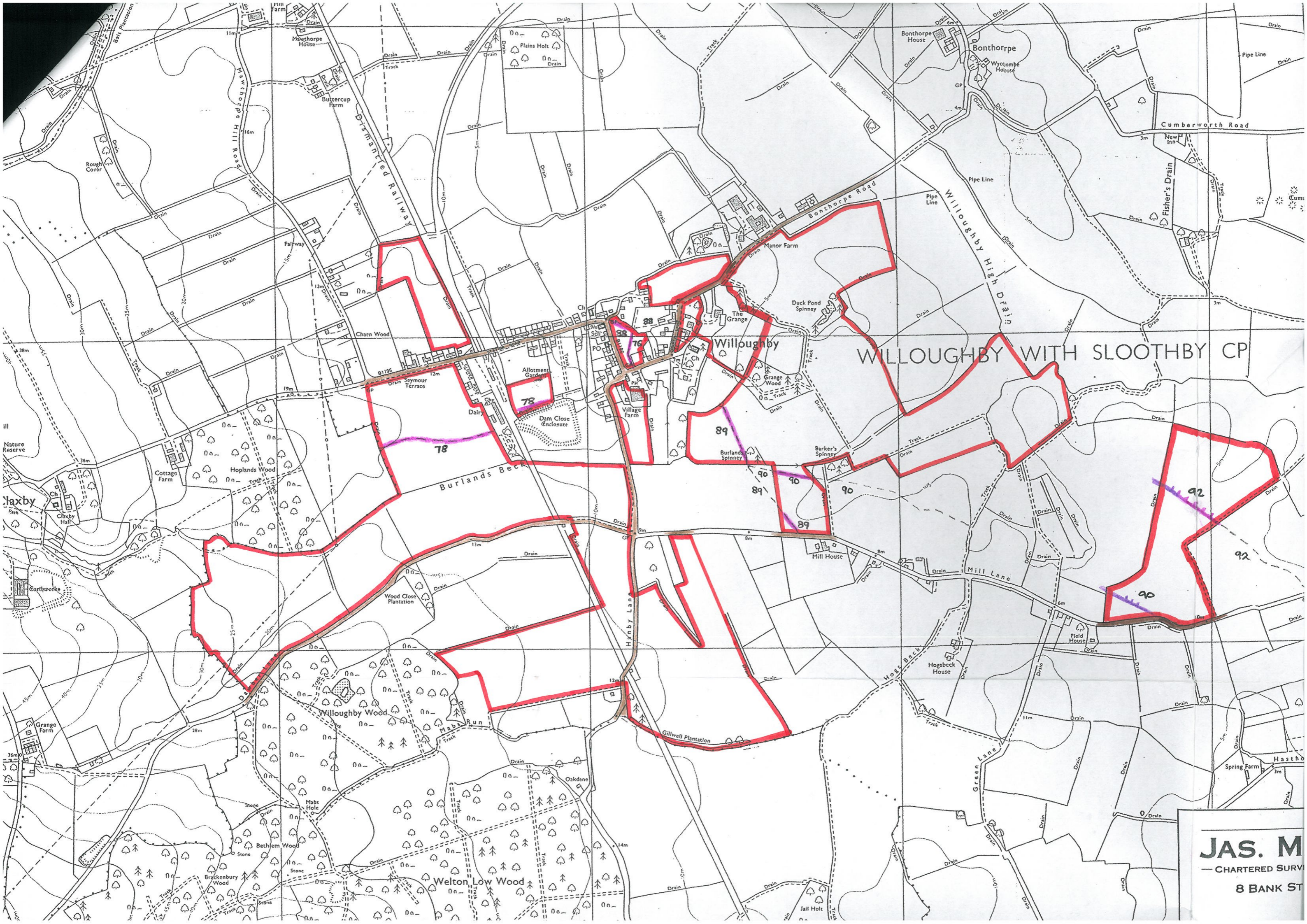
88 Footpath from Station Road at TF 4707 7204 proceeding across land leased for use as a village green in an E. direction for 85m to Kissing Gate at TF 4714 7203.

92 Footpath from an easterly/westerly direction crossing over field no. 9342 of the metric edition of the Ordnance Survey Map.

The farm access road shown shaded brown on plan SNR4B is indicated in the result of an enquiry of the County Council to be a highway maintainable at the public expense. But, in fact, it is not and the Landowner denies it has ever been dedicated.
