

This requirement overrides any entitlement a depositor and landowner may otherwise have under the Data Protection Act 1998 to prevent the publication of such information.



- 6. The deposit shall comprise this statement and accompanying plan.



STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980 (As amended by the Countryside Rights of Way Act 2000)

I, Michael Cornish DO SOLEMNLY AND SINCERELY DECLARE as follows;

- 1. I am and have been since October 2005 the owner of the land known as Hallgarth Farm in the parish of Thimbleby more particularly delineated on the map accompanying this declaration and thereon edged red.
- 2. On the 2nd day of November 2009 I deposited with Lincolnshire County Council, being the appropriate Council, a statement accompanied by a map delineating my property by red edging which stated the ways coloured green on the said map and on the map accompanying this declaration had been dedicated as bridleways and the ways coloured purple on the said map and map accompanying this declaration had been dedicated as footpaths and no other ways had been dedicated as highways over my property.
