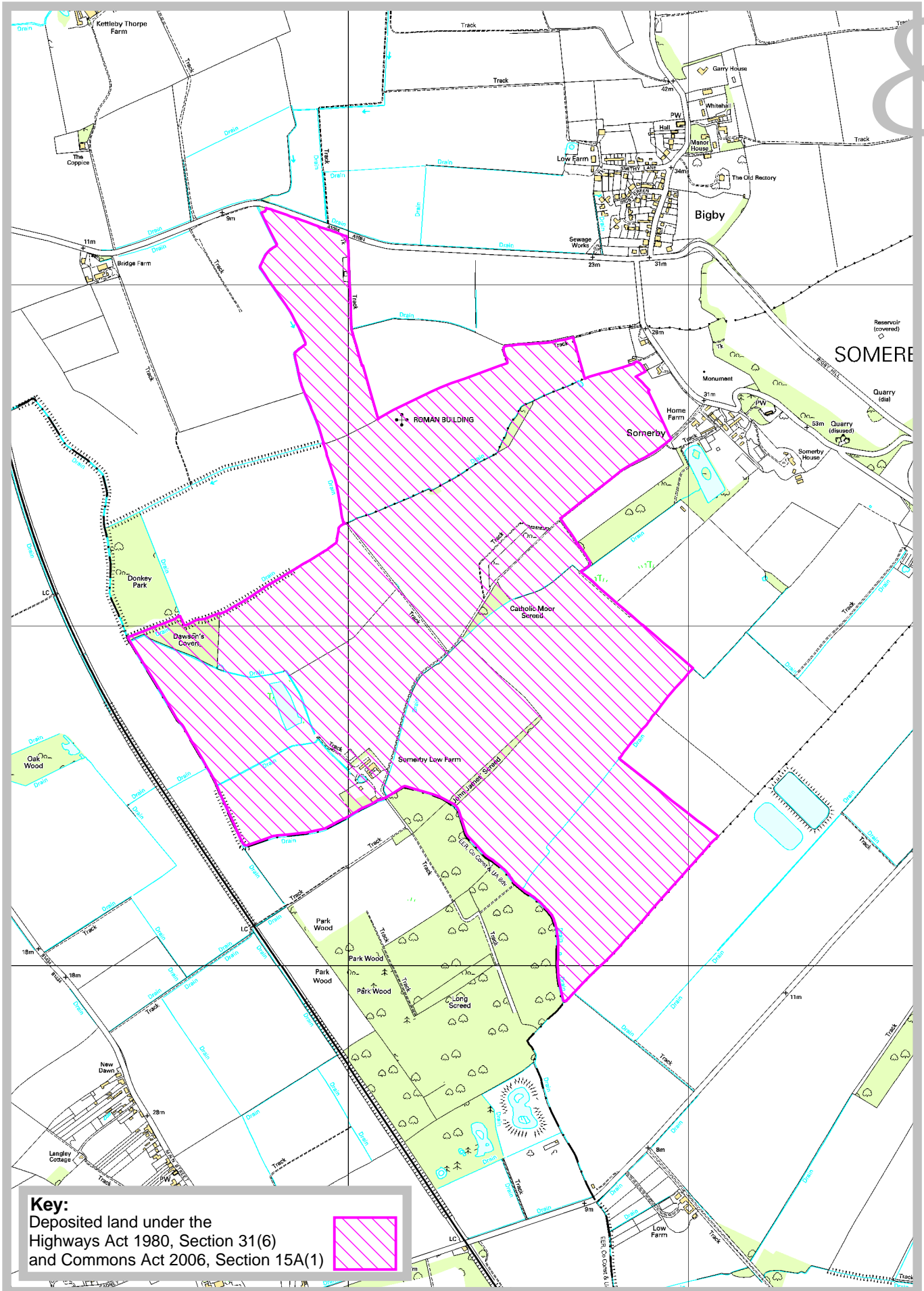


**REGISTER OF DEPOSITS**

This requirement overrides any entitlement a depositor may otherwise have under the Data Protection Act 1998 to prevent publication of such information. 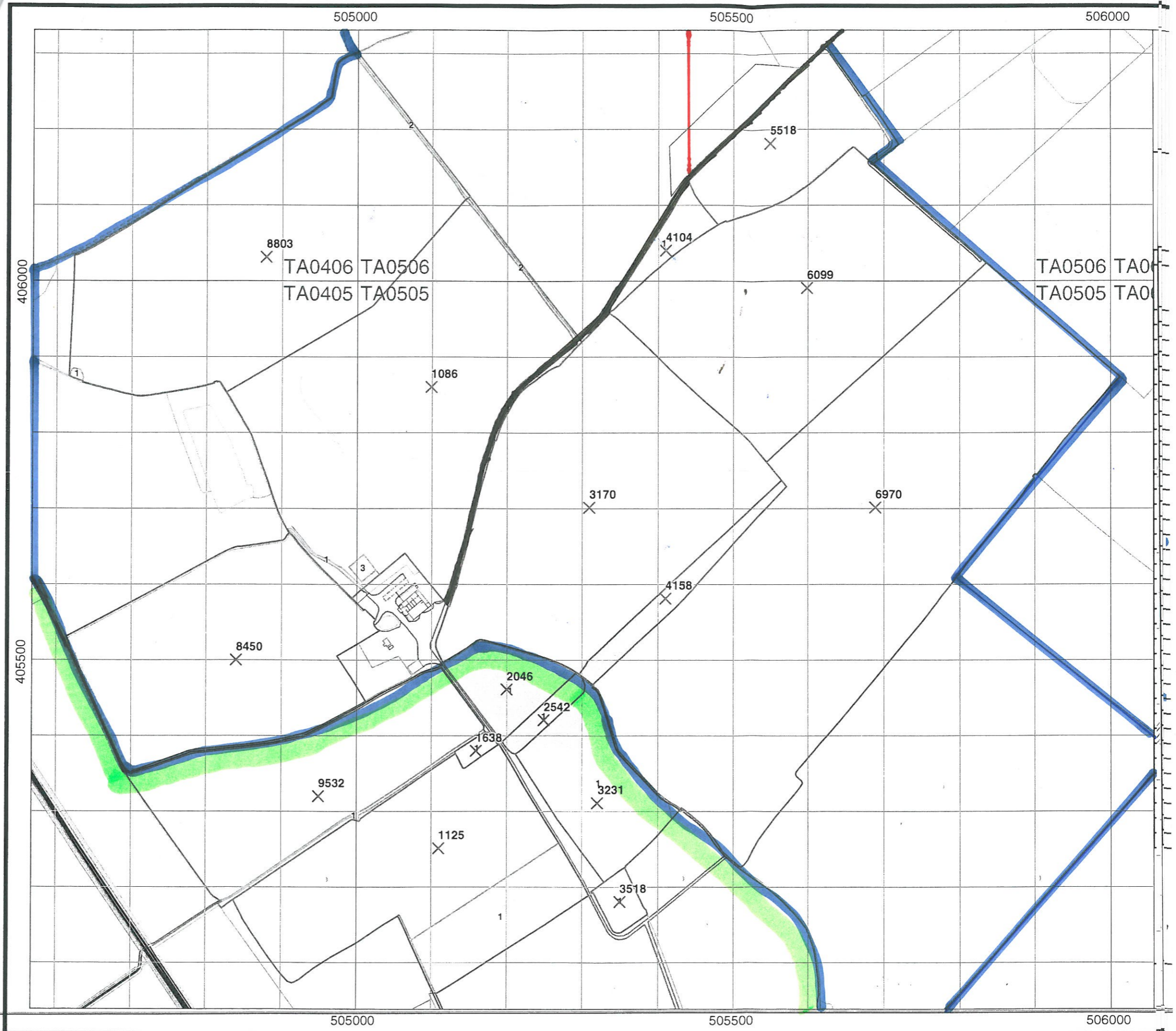

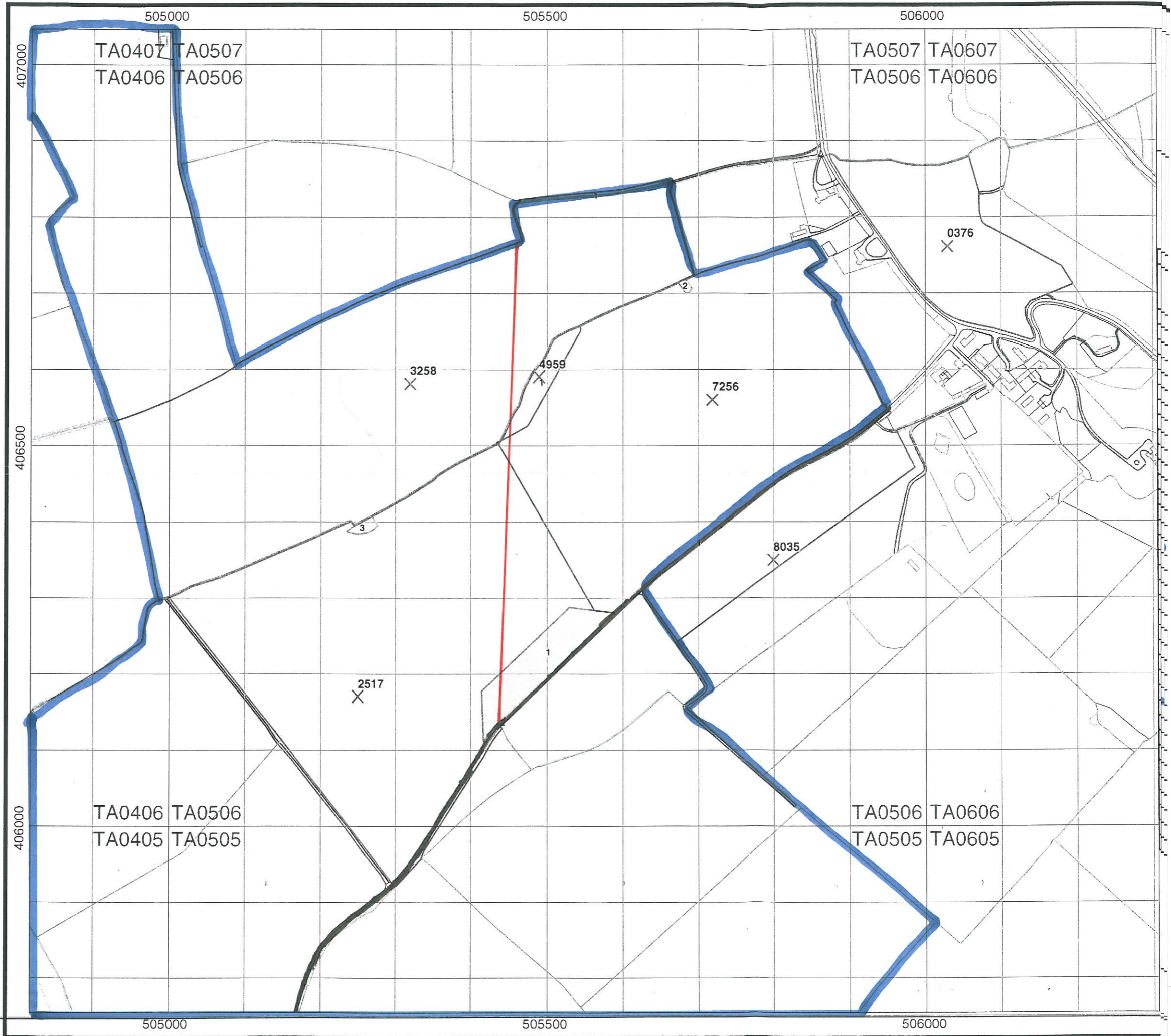
