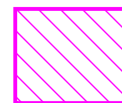
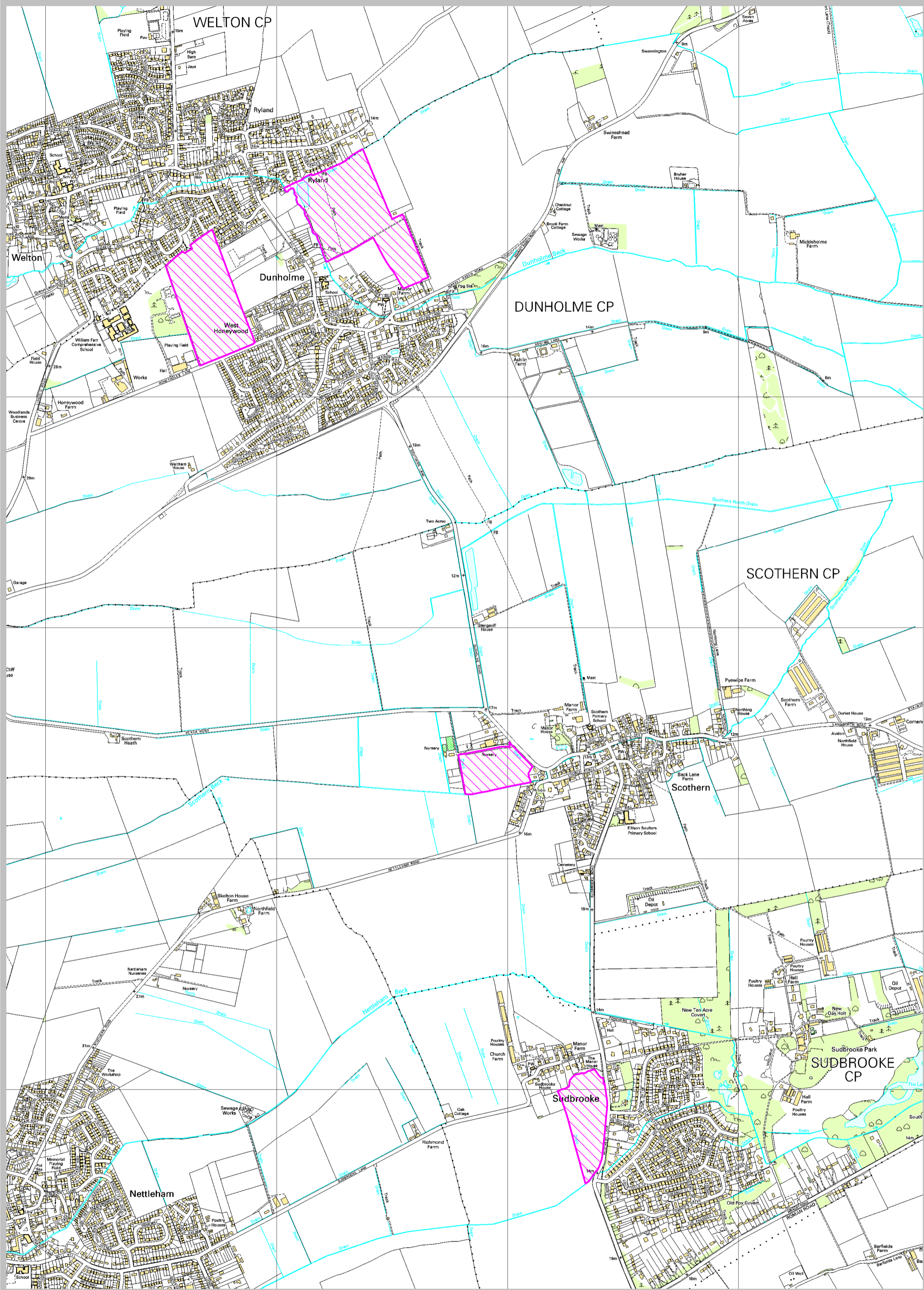

## **REGISTER OF DEPOSITS**

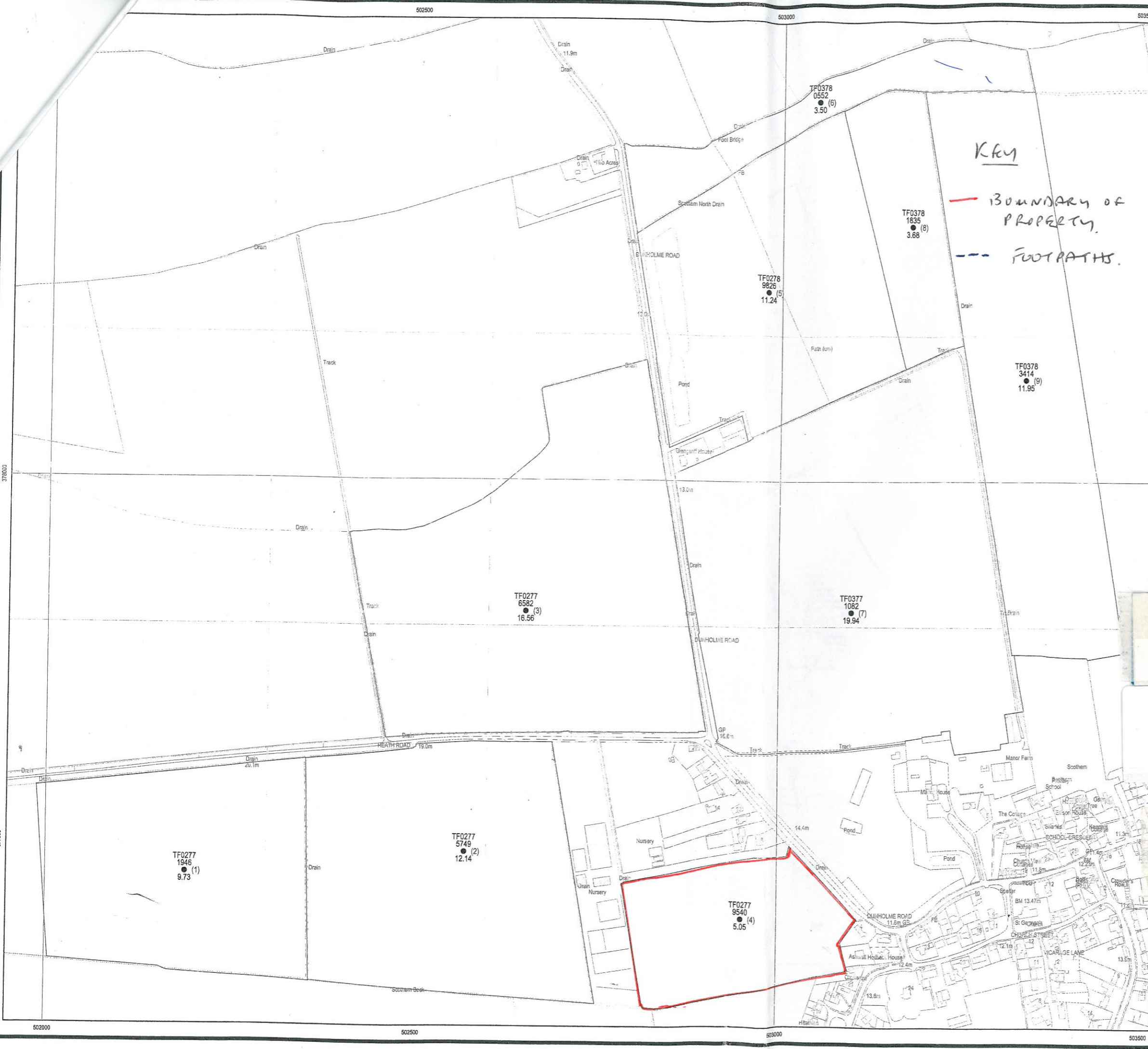












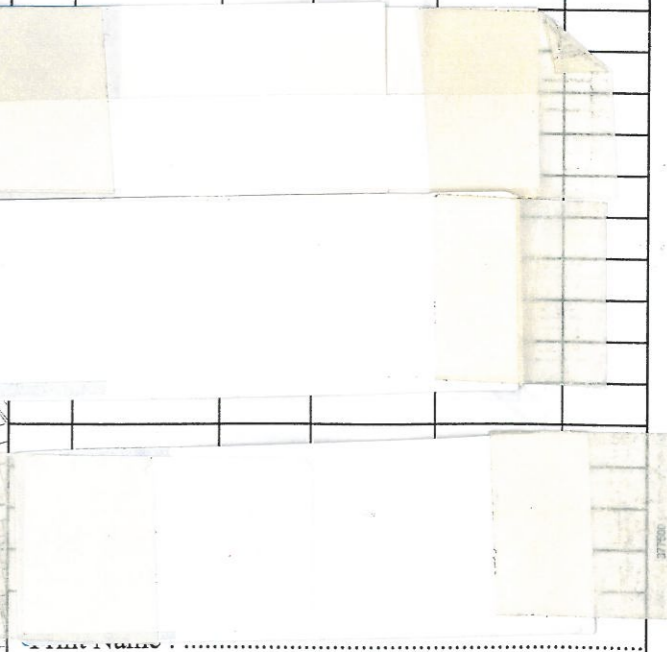
