

# **PUBLIC NOTICE**

## **LINCOLNSHIRE COUNTY COUNCIL (LINCOLN, BOSTON, GRANTHAM & SLEAFORD – VARIOUS ROADS) (PROHIBITION OF WAITING) EXPERIMENTAL AMENDMENT ORDER 2018**

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council has made an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to impose an Experimental Order as set out in the Schedule below.

The Order will come into operation on **10 September 2018** and a copy of the proposed Order and a plan showing the lengths of road concerned with a Statement of Reasons may be inspected at the address given below and the offices of the relevant District Council, during normal office hours.

Representations or objections to the proposals, together with the grounds on which they are made, must be sent in writing to R A Wills - Executive Director (Environment & Economy), Lincolnshire County Council, Lancaster House, 36 Orchard Street, Lincoln, LN1 1XX, (For the attention of: Mrs T Featherstone, Traffic Orders Section) by **10 March 2019**. Lincolnshire County Council will be considering in due course whether the provisions of the Order should continue in force indefinitely together with any representations or objections received.

Any person who desires to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order may within 6 weeks after 7 September 2018 make application to the High Court for this purpose.

**(PROHIBITION OF WAITING) EXPERIMENTAL AMENDMENT ORDER 20**

**STATEMENT OF REASONS**

- Following investigations at the above mentioned locations it was found that during peak school drop off/pick up times vehicles are parked/waiting on the advisory 'School Keep Clear' markings.
- The introduction of a formal Traffic Regulation Order will hopefully discourage parking/waiting on the school keep clear markings and enable civil parking enforcement officers to issue Penalty Charge Notices where appropriate.
- The revised experimental order has made provisions for bus stands at two of the locations.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, Parish Councils and District Councils have been consulted, along with other local groups/companies.
