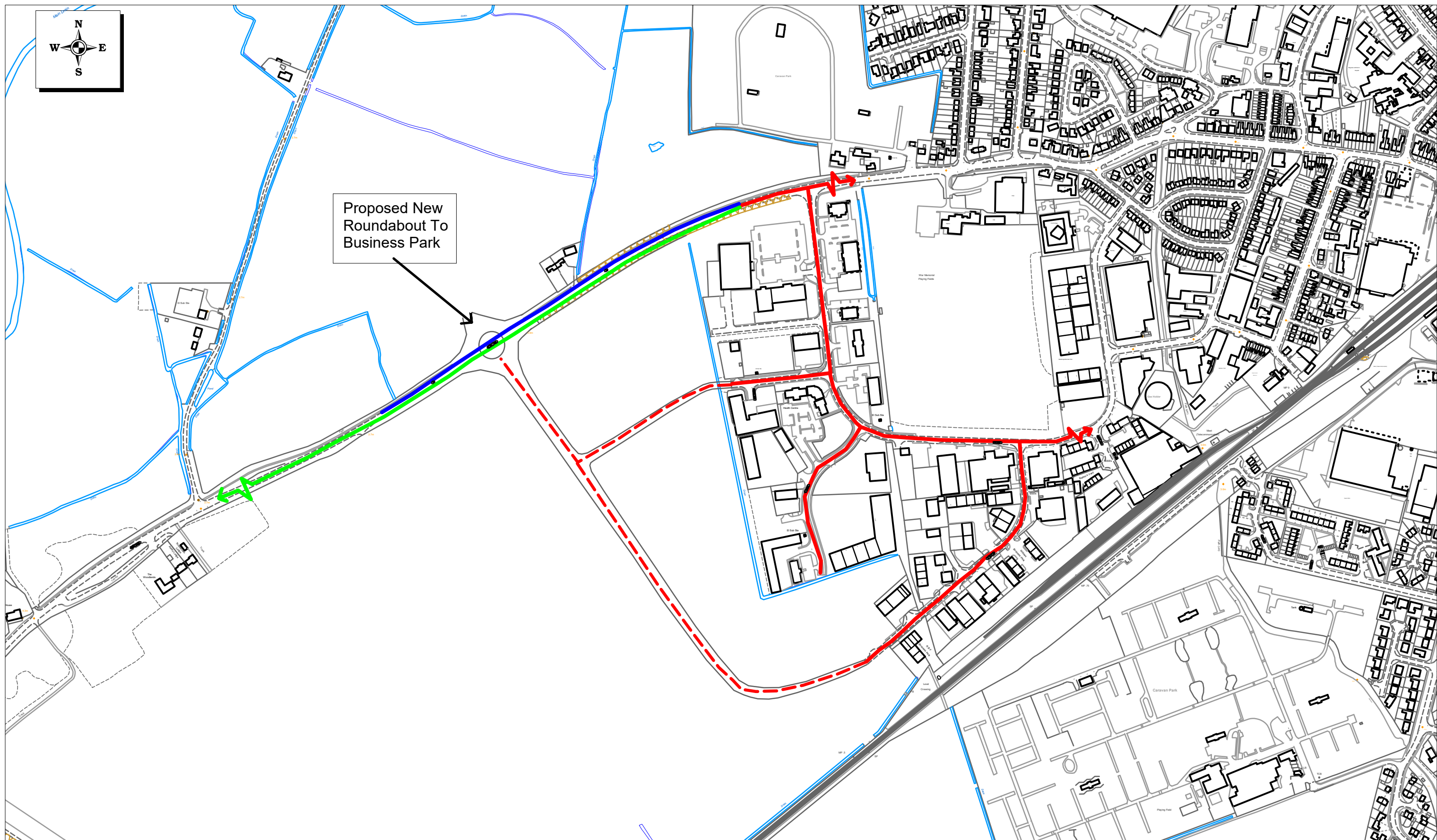
#### **Skegness Business Park off A52 Wainfleet Road**
