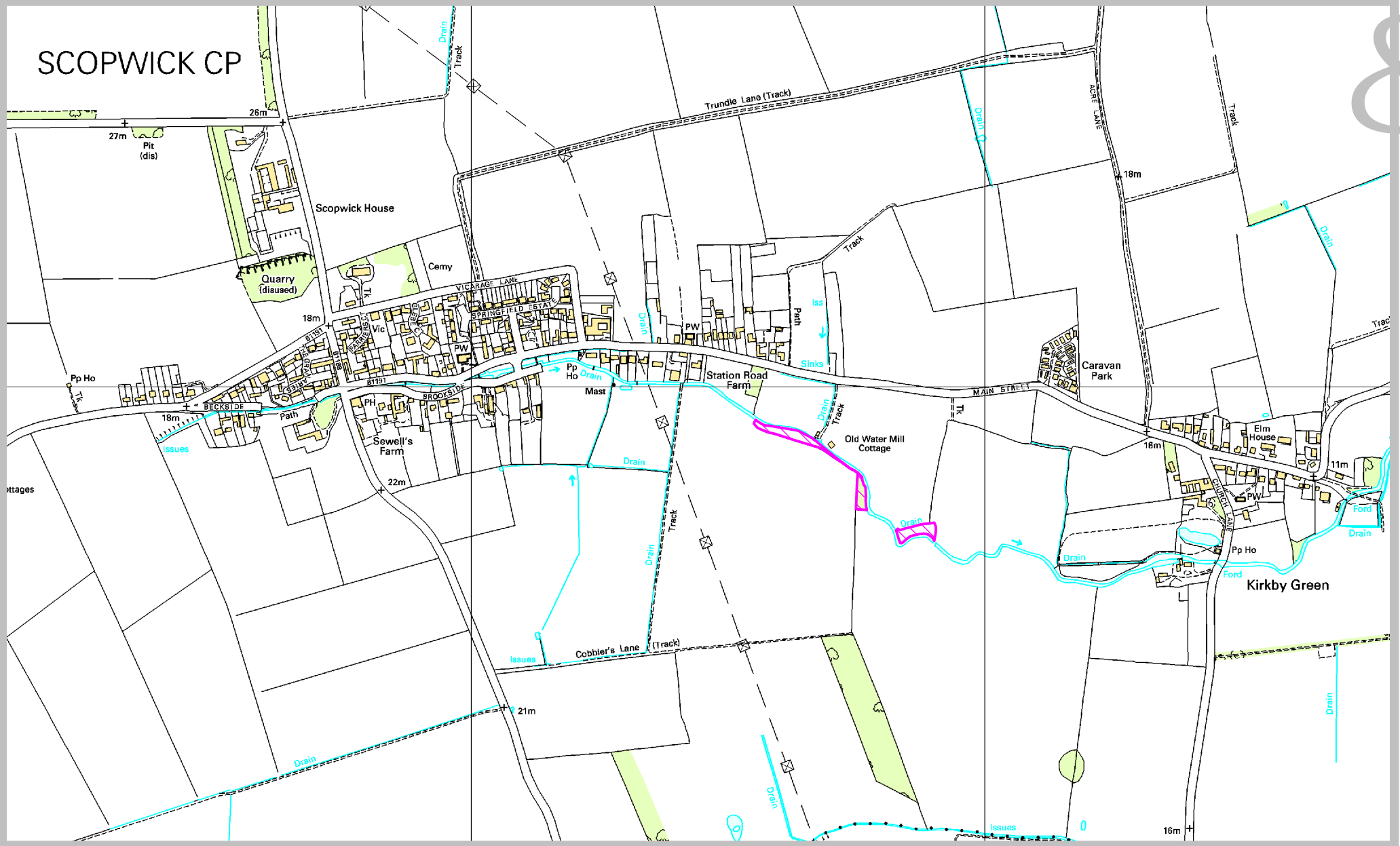

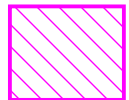

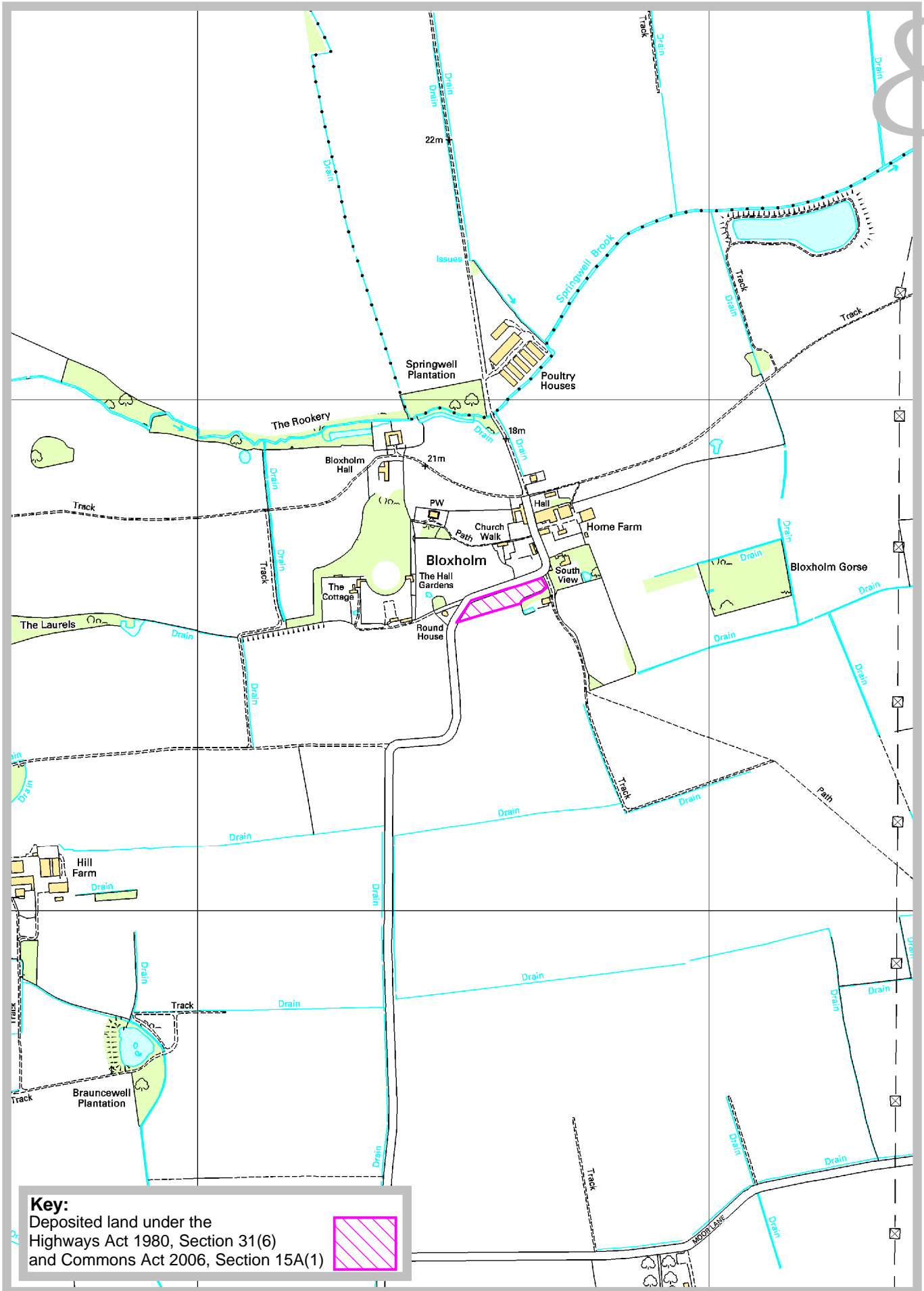
Land at Bloxholm and Scopwick

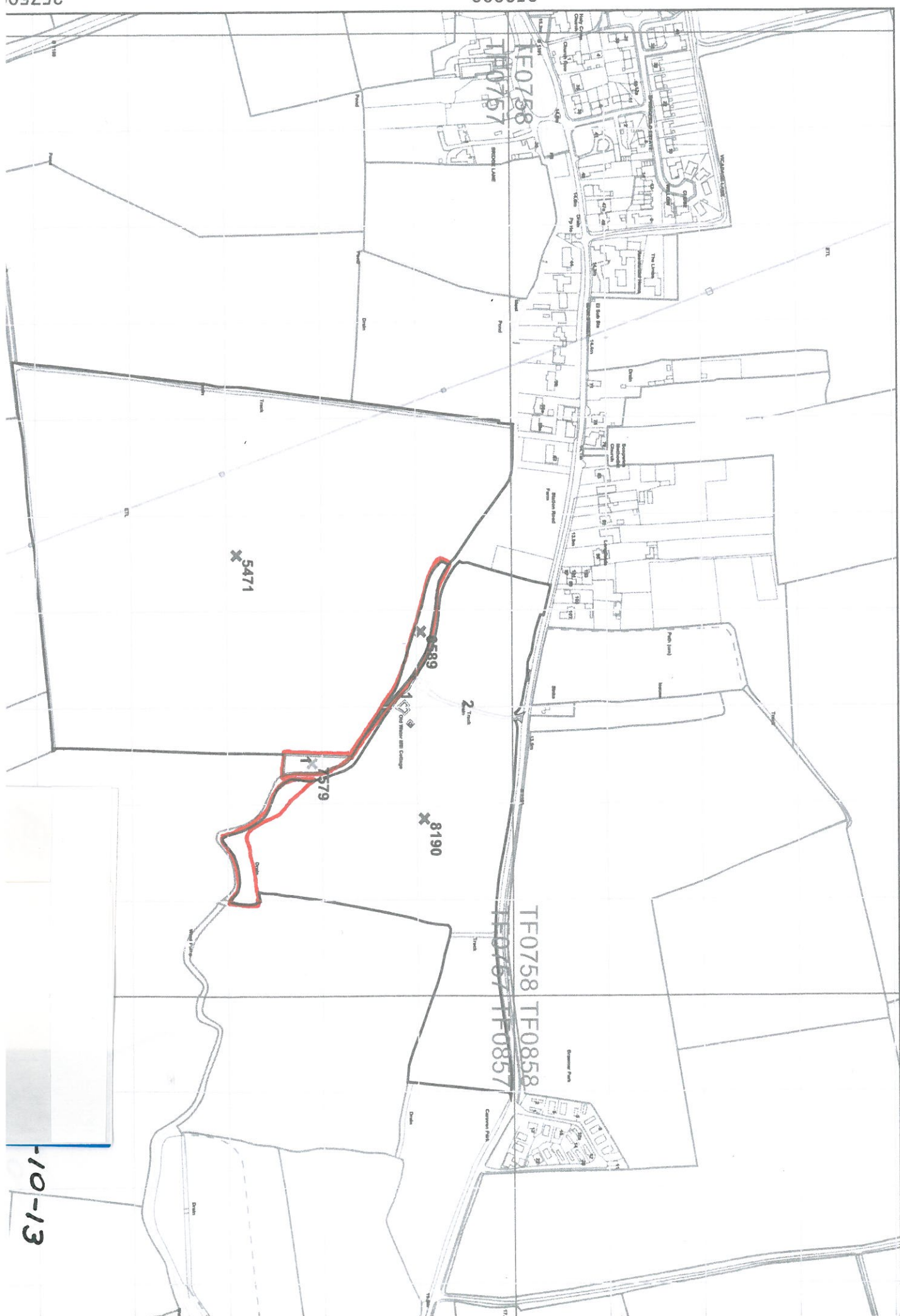
MAP 1 OF 2: SCOPWICK
