MODIFICATION ORDER 2020

This Order is made by Lincolnshire County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement for the area of the former South Kesteven Rural District Council require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the Act namely the coming into operation of any enactment or instrument, or any other event whereby a highway shown to be in the map and statement has been authorised to be stopped up, diverted, widened or extended and in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the Act namely the coming into operation of any enactment or instrument, or any other event whereby a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path

Now therefore Lincolnshire County Council in exercise of the powers confirmed on them by Section 53(2)(b) hereby make the following Order:

1. For the purposes of this Order the relevant date is 28 January 2020
2. The Kesteven County Council Definitive Map and Statement for the area of the former South Kesteven Rural District Council shall be modified as described in Part I and Part II of the Schedule and shown on the plans annexed hereto
3. This Order shall take effect on the date it is made and may be cited as the Lincolnshire County Council, Amendment of Kesteven County Council, Rural District of South Kesteven, Definitive Map and Statement - Legal Event (No.1) Modification Order 2020

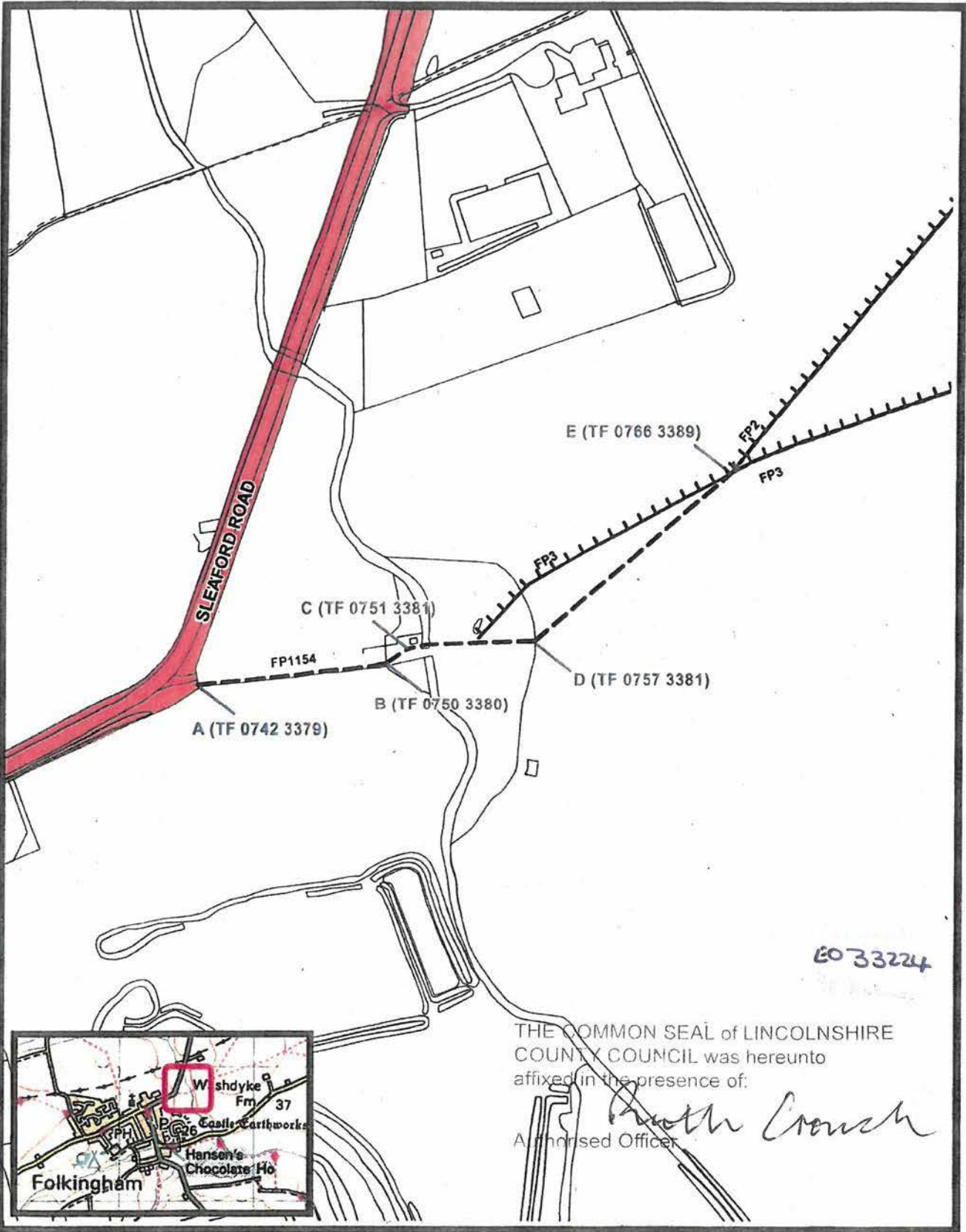

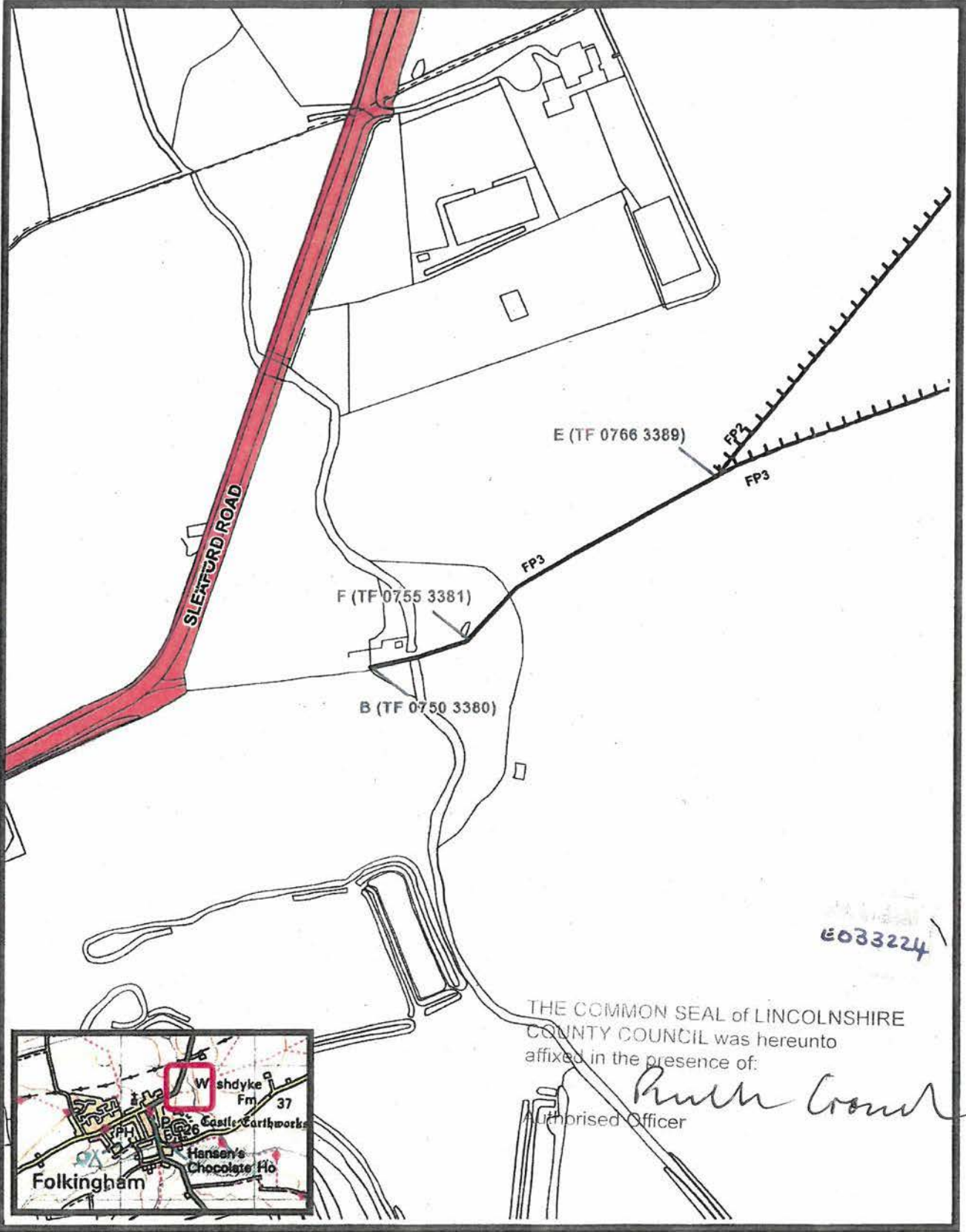
