ADDITION OF RESTRICTED BYWAY NUMBER 1170 HEAPHAM

DEFINITIVE MAP MODIFICATION ORDER 2020

This Order is made by Lincolnshire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement for the area of the Lindsey County Council (Rural District of Gainsborough) require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a restricted byway

The Authority has consulted with every local authority whose area includes the land to which the Order relates

1. For the purposes of this Order the relevant date is 12 March 2020

2. The Lincolnshire County Council Definitive Map and Statement for the area of the Lindsey County Council (Rural District of Gainsborough)

shall be modified as described in Part I and Part II of the Schedule and shown on the Drawing attached to this Order

3. This Order shall take effect on the date it is confirmed and may be cited as the Lincolnshire County Council, Addition of Restricted Byway Number 1170 Heapham, Definitive Map Modification Order 2020

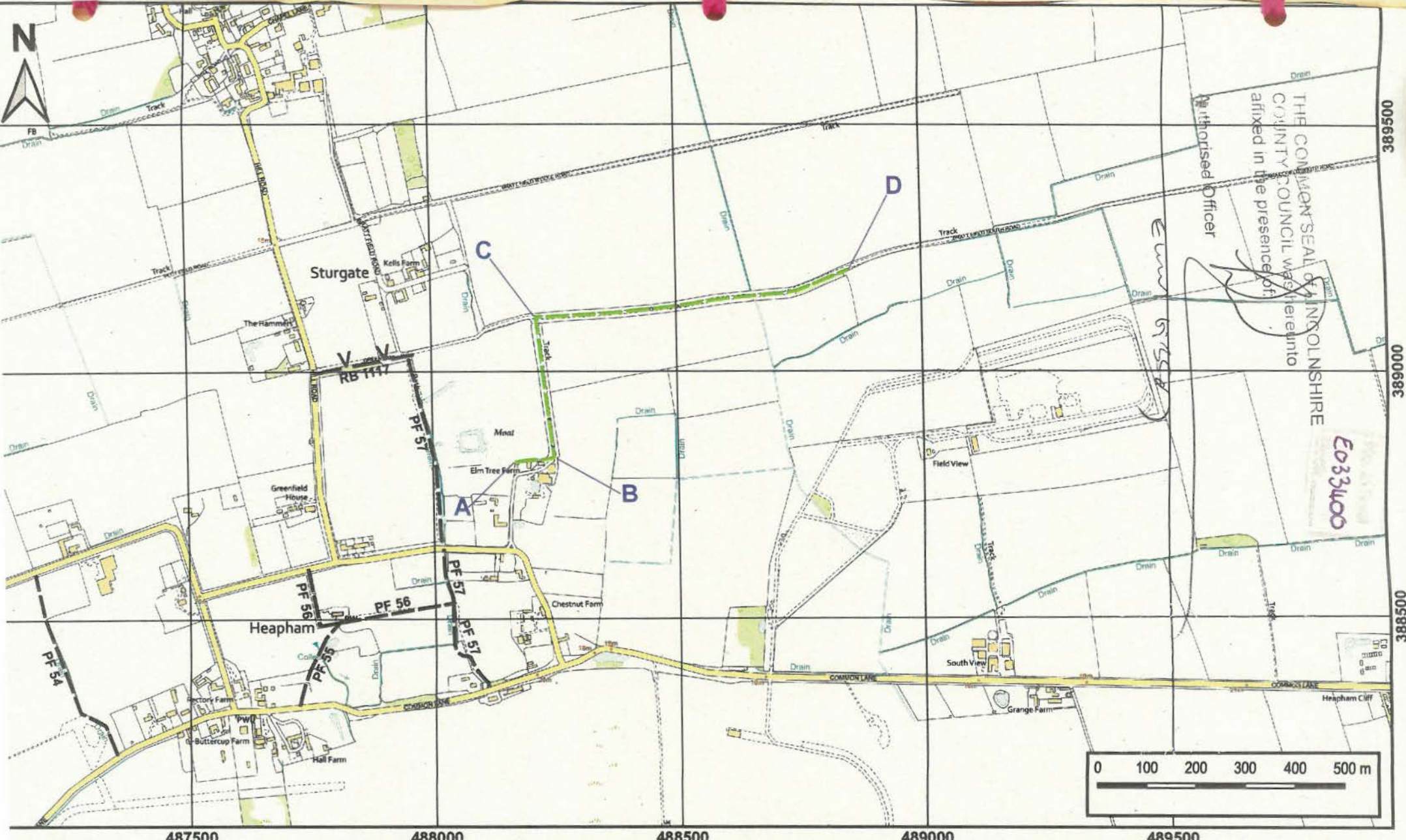

In the Parish of Heapham

Restricted Byway No. 1170

- (i) A restricted byway having a width of 6 metres and running in an easterly direction from Ordnance Survey Grid Reference (OSGR) SK 8817 8881 (Point A on Order Drawing No. 2020/003/DMMO394/A4) for a distance of approximately 77 metres to OSGR SK 8824 8882 (Point B) then running in a generally northerly direction, having a width of 18 metres (imperial measurement of 60 feet) for a distance of approximately 281 metres to OSGR SK 8821 8910 (Point C), then running in a generally easterly direction, bounded to the north by Springthorpe Parish and having a width of 18 metres for a distance of approximately 647 metres to OSGR SK 8884 8920 (Point D) at the parish boundary with Springthorpe. 

A restricted byway having a width of 6 metres and running in an easterly direction from Ordnance Survey Grid Reference (OSGR) SK 8817 8881 for a distance of approximately 77 metres to OSGR SK 8824 8882 then running in a generally northerly direction, having a width of 18 metres (imperial measurement of 60 feet) for a distance of approximately 281 metres to OSGR SK 8821 8910, then running in a generally easterly direction bounded to the north by Springthorpe Parish and having a width of 18 metres for a distance of approximately 647 metres to OSGR SK 8884 8920 at the parish boundary with Springthorpe. Total length of the restricted byway to be 1,005 metres.
