DEFINITIVE MAP MODIFICATION ORDER 2020

This Order is made by Lincolnshire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement for the area of the former Rural District of Horncastle require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(iii) of the Act namely that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification

The Authority has consulted with every local authority whose area includes the land to which the Order relates

1. For the purposes of this Order the relevant date is 10 March 2020

2. The Lincolnshire County Council Definitive Map and Statement for the area of the former Rural District of Horncastle shall be modified as described in Part I and Part II of the Schedule and shown on the Drawing attached to this Order

3. This Order shall take effect on the date it is confirmed and may be cited as the Lincolnshire County Council, Deletion of Part of Benniworth Public Footpath Number 9, Definitive Map Modification Order 2020

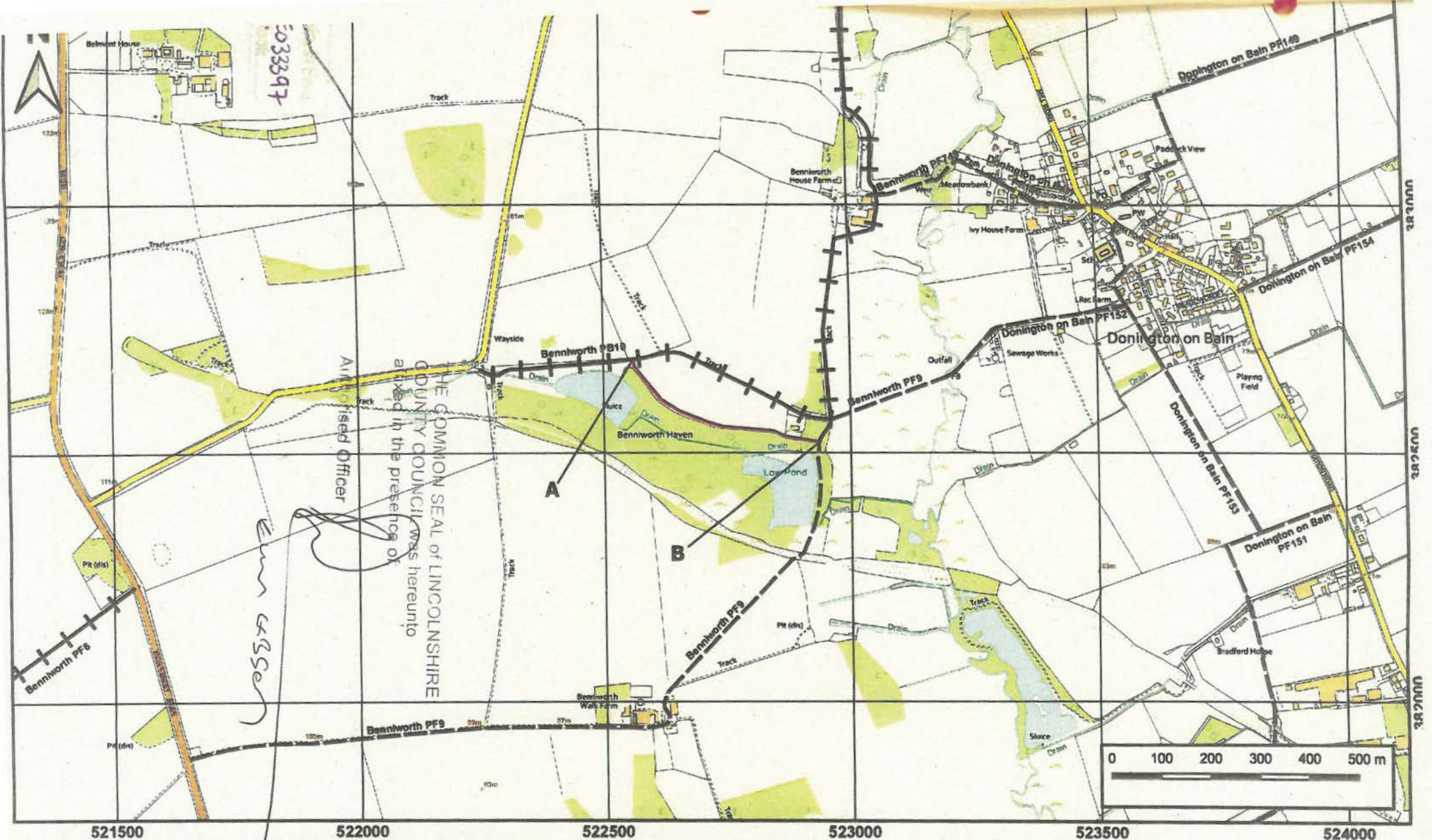


