

**LINCOLNSHIRE COUNTY COUNCIL

(PROHIBITION OF WAITING) AMENDMENT ORDER 20**

STATEMENT OF REASONS

- Concerns have been expressed with regards to on street parking in the area.
- Options have been investigated as to how best to resolve this situation without unduly affecting the parking situation elsewhere.
- The proposals will remove any parked vehicles during the times stated and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Metheringham Parish Council and North Kesteven District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to:

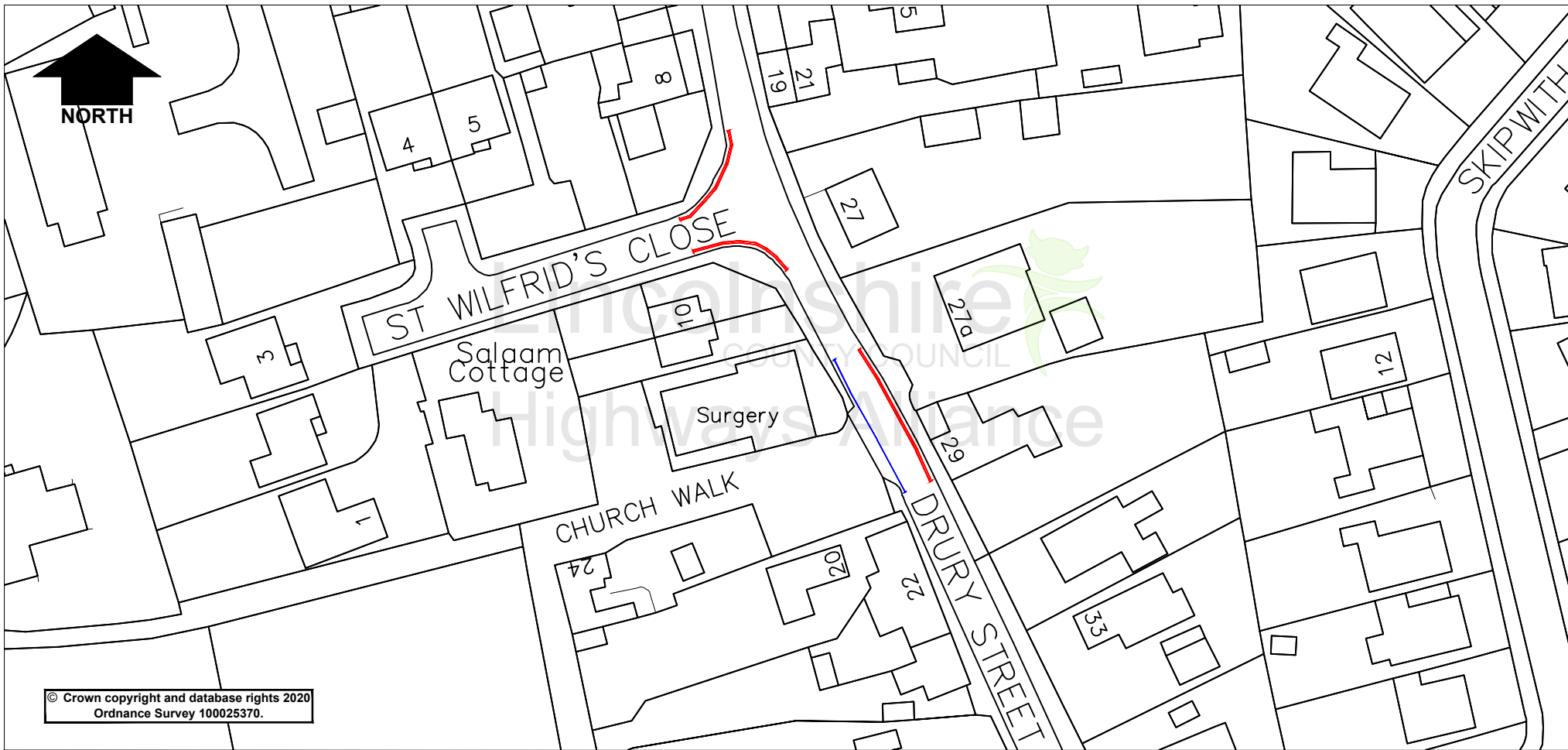
- ❖ Prohibit waiting on Drury Street in front of the junction of Church Walk, between 8:00am and 18:30pm Monday – Friday
- ❖ Prohibit waiting at any time in front of properties 29 and 27a
- ❖ Prohibit waiting at any time around the junction of St Wilfrid's Close

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
