STATEMENT OF REASONS

- Investigations have taken place at the location above with a view to improving safety in the vicinity of the school
- Vehicles have regularly been observed parking inconsiderately resulting in difficulties for all road users and raising safety concerns.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, It is proposed to introduce No Waiting at Any Time at the various junctions in the vicinity and a Bus Stand, Monday – Friday, 08:00am -09:30am and 02:30pm -04:00pm directly outside the school is also proposed.
- The Chief Constable, Grasby Parish Council and West Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce small sections of No Waiting at Any Time in the vicinity of the school and at the following junctions – Church Side, Main Street, Church Hill and Clixby Lane and a Bus Stand, Monday – Friday, 08:00am -09:30am and 02:30pm -04:00pm directly outside the school is also proposed.

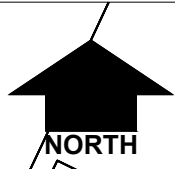
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.

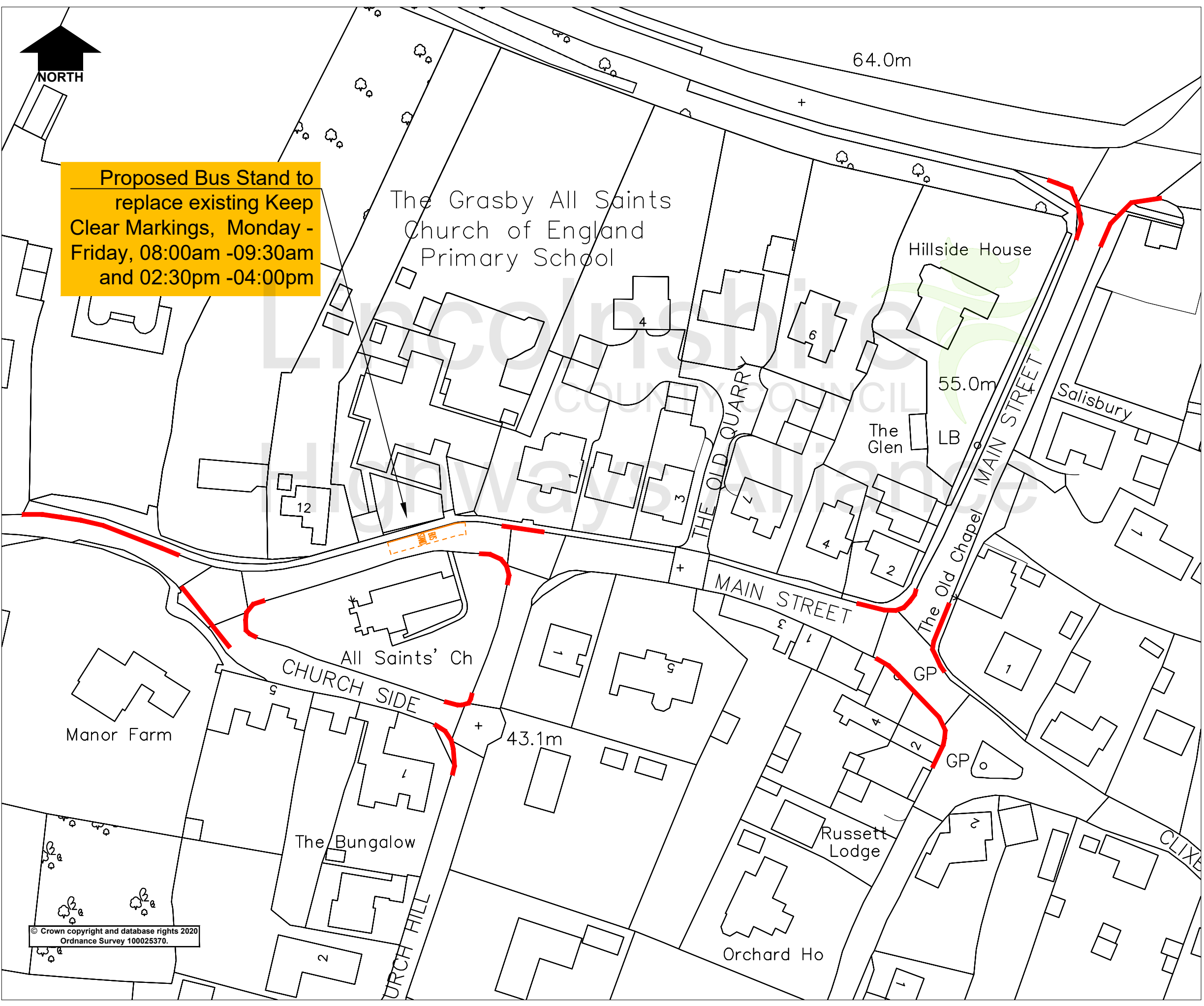
