hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Lincolnshire Definitive Map and Statement for the District of West Lindsey by

- Adding a bridleway in the parish of Bishop Norton from point **E1** on Atterby Carr Road to point **E2** on The footpath Bishop Norton 68/2
- Adding a bridleway in the parishes of Snitterby and Bishop Norton from point **E3** on the footpath Snitterby 68/1 to point **E4** on the footpath Bishop Norton 68/1
- Adding a bridleway in the parishes of Snitterby and Bishop Norton from point **E5** on Snitterby Carr Lane to point **E6** on the eastern side of the bank of the New Ancholme River
- Upgrading to a bridleway the footpath known as Bishop Norton 68/2 for point **E2** to point **E3** and on the footpath Bishop Norton 68/1 from point **E4** to point **E5** on Snitterby Carr Lane
