STATEMENT OF REASONS

- Investigations have taken place at the location above with a view to providing limited waiting in the area.
- Inconsiderate parking occurs at the above locations causing safety concerns for other road users.
- Therefore, in accordance with the County Council's Policy, it is proposed to introduce limited waiting as per the consultation plan.
- The Chief Constable, Weston Parish Council and South Holland District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting on St Johns Road, Carisbrooke Way and Broadgate in Weston.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
