

**LINCOLNSHIRE COUNTY COUNCIL  
(GAINSBOROUGH – NORTH MARSH ROAD)  
(PROHIBITION OF WAITING) AMENDMENT ORDER 2023**

**STATEMENT OF REASONS**

- Following investigations at the above mentioned location it was found that during peak school drop off/pick up times there are vehicles parked/waiting on the advisory 'School Keep Clear' markings.
- The introduction of a formal Traffic Regulation Order will discourage parking/waiting on the 'School Keep Clear' markings and enable civil parking enforcement officers to issue Penalty Charge Notices where appropriate. No Waiting at any time will also manage any inconsiderate parking within the area,
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, Gainsborough Town Council and West Lindsey District Council have been consulted, along with other local groups/companies.

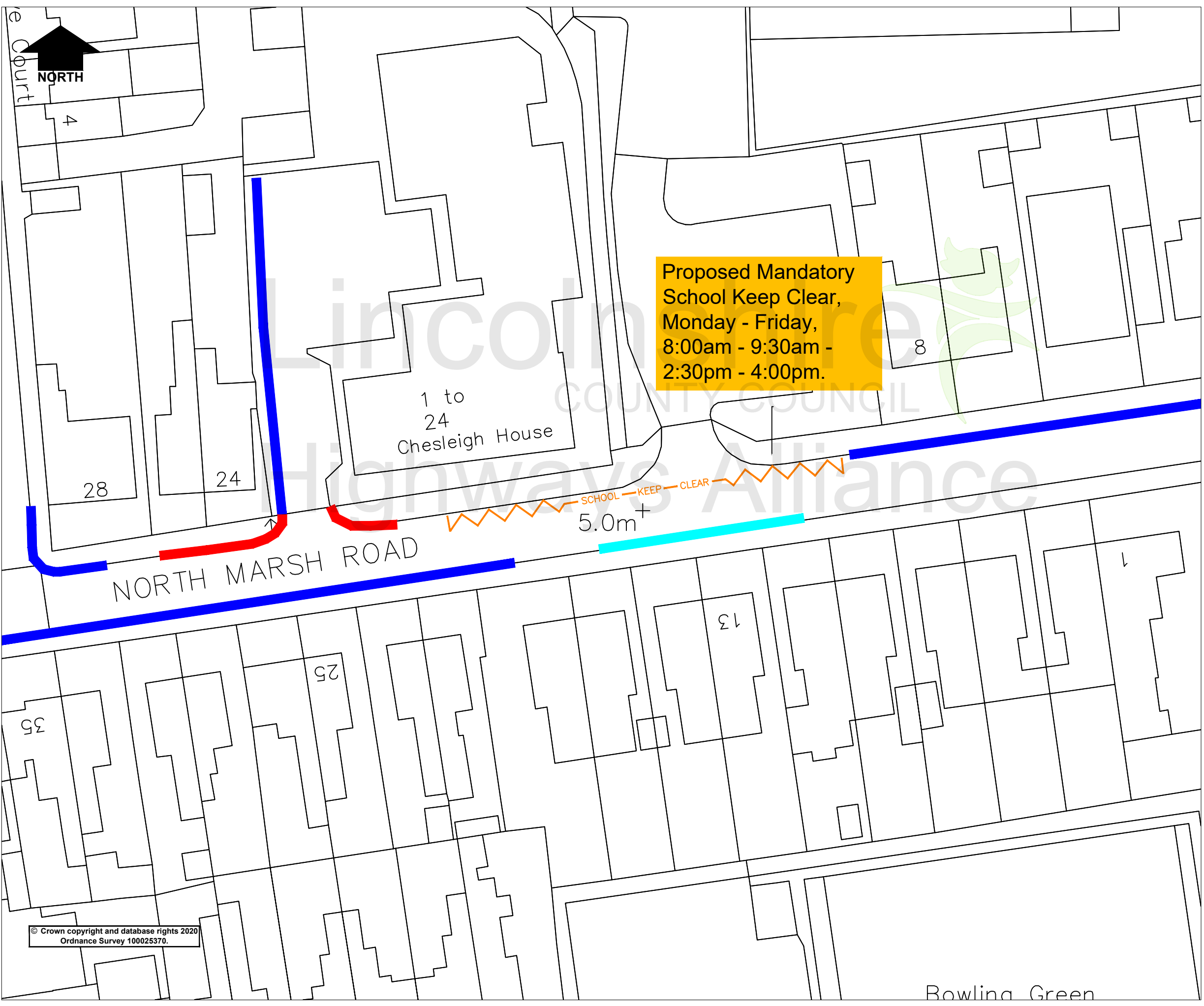
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
