5. The deposit shall comprise this statement and accompanying map.

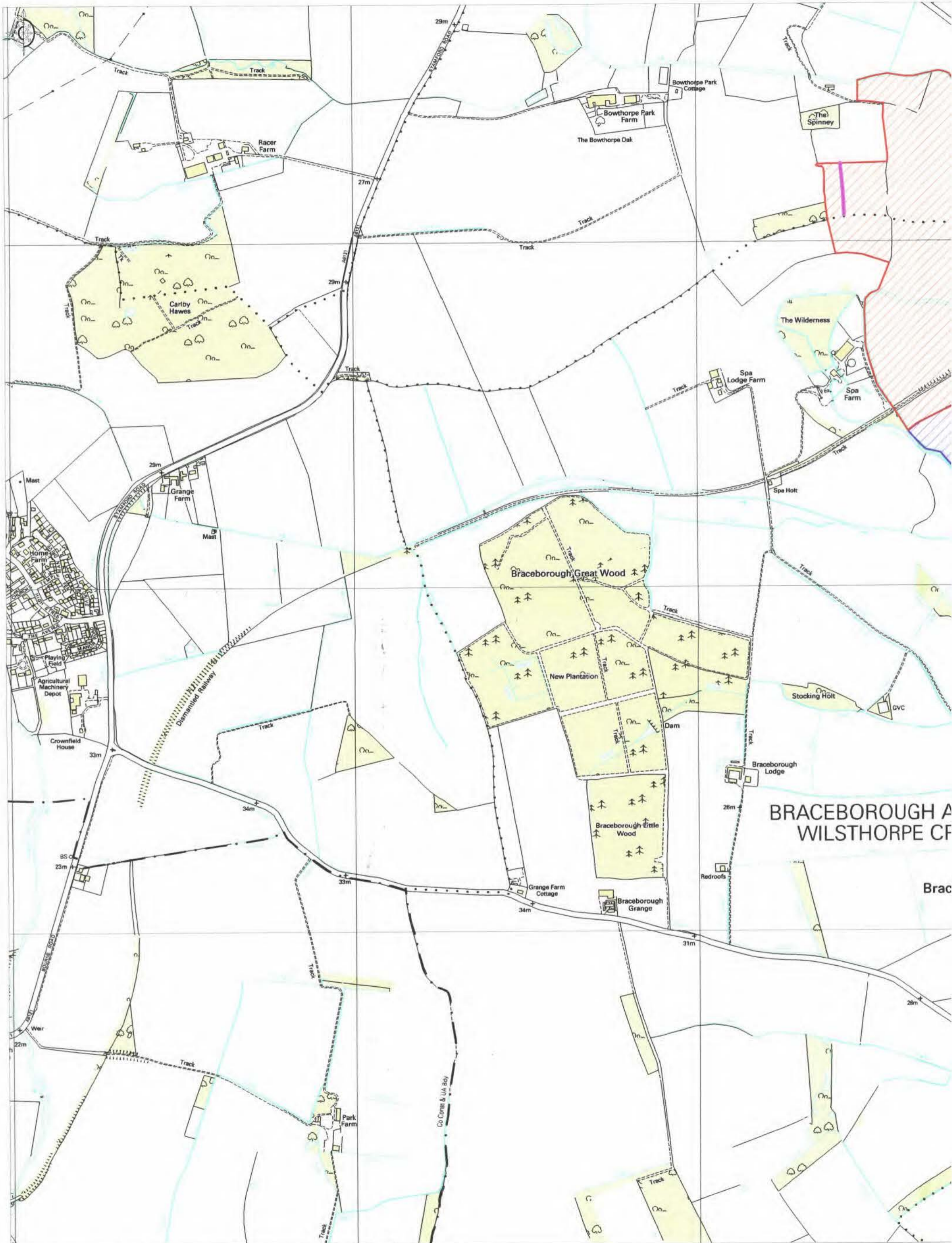

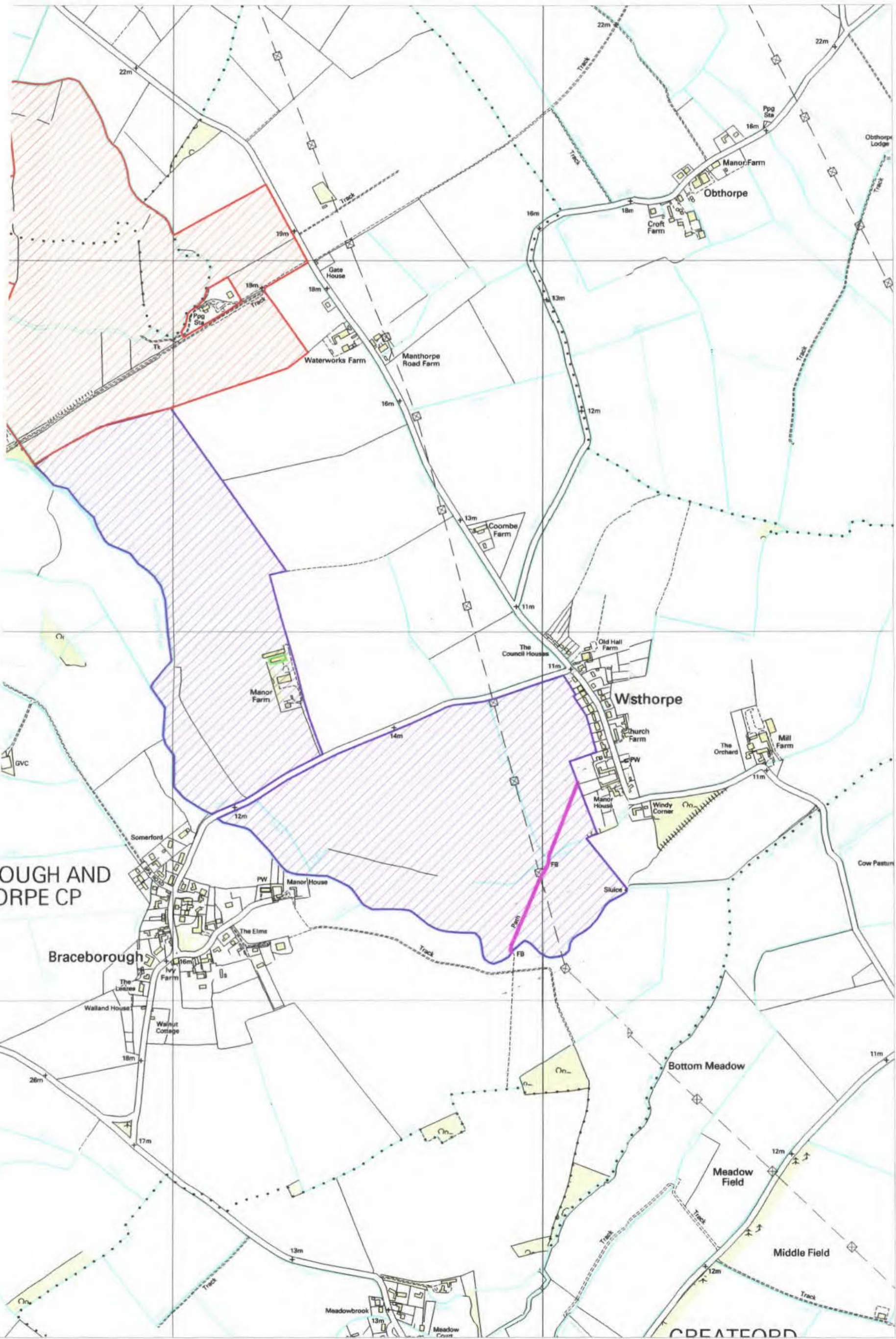


