NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will:

- Prohibit waiting west of Adam Heath House to cover the access to the car park.
- Limit waiting Monday – Saturday 8am – 6pm 2 hours, no return within 2 hours in the vicinity of 53 – 49 Gaunt Street, the walkway to Witham Mews and 41 Gaunt Street and outside Adam Heath House.

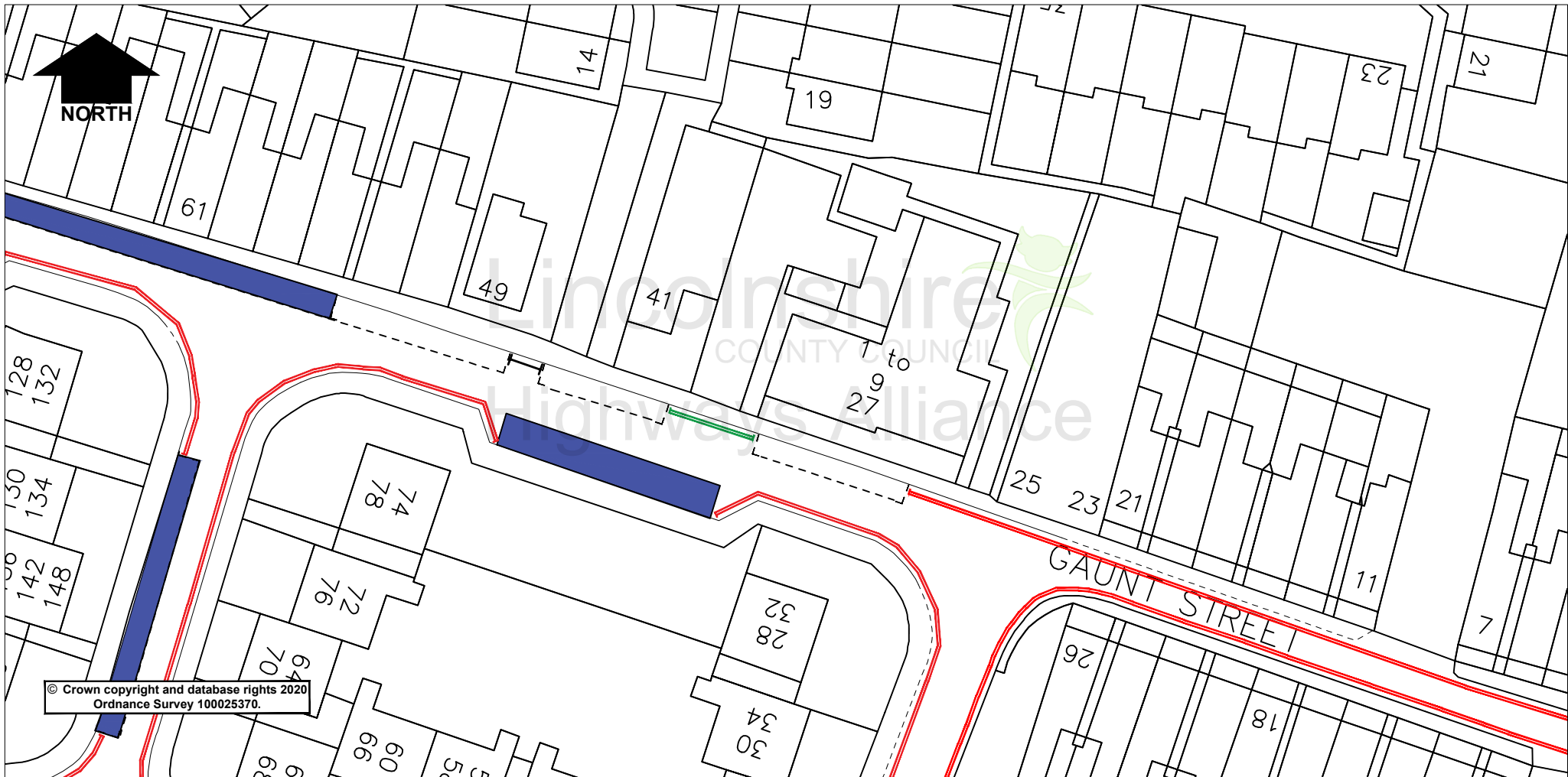
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
