

**LINCOLNSHIRE COUNTY COUNCIL

**STATEMENT OF REASONS**

- Following investigations at the above mentioned location it was found that H Bar markings are over used.
- Lincolnshire County Council's Policy is to review these markings before road resurfacing is to take place and provide a permanent and enforceable solution if the problem is long term.
- The proposals will remove obstruction of the highway by parked vehicles, facilitate traffic flow, ensure all accesses are kept clear and to improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, Heckington Parish Council and North Kesteven District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting on St Andrews Street, Heckington.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
