 - Adding a footpath in the parish of Gate Burton from point **B** to point **C** on the Willingham Parish boundary
 - Adding a footpath in the parish of Willingham from point **C** to point **D** on the Knaith parish boundary.
 - Adding a footpath in the parish of Knaith from point **D** to point **E** on Kexby Lane
 - Adding a footpath in the parish of Willingham from point **D** to point **F** on Marton Road
 - Adding a footpath in the parish of Willingham from point **B** to point **G** on Marton Road
