STATEMENT OF REASONS

- Investigations have taken place at the location above with a view to providing limited waiting in the area.
- A School Crossing Patrol operates in the vicinity of the junctions with Commercial Road and Lacey Gardens and on street parking on Eastgate obstructs forward visibility for traffic on the southern approach to this area.
- Therefore, in accordance with the County Council's Policy, it is proposed to introduce limited waiting as per the consultation plan.
- The Chief Constable, Louth Town Council and East Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to No Waiting at Any Time on Eastgate Louth in the vicinity of properties no 2, 3 and 203.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
