(CROWLAND – REFORM STREET)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2024

STATEMENT OF REASONS

- Concerns have been raised with regards to loss of on street parking in the vicinity of No.72 and No.74 Reform Street, Crowland. Following investigations it would appear that the revocation of the existing restriction should not have a detrimental effect to safety and traffic flow.
- Investigations have also shown that parked vehicles are causing an obstruction of the highway when parking on the existing No Waiting Mon-Fri – 8am-6pm. The proposals will remove obstruction of the highway by parked vehicles, facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, Crowland Parish Council and South Holland District Council have been consulted, along with other local groups/companies.

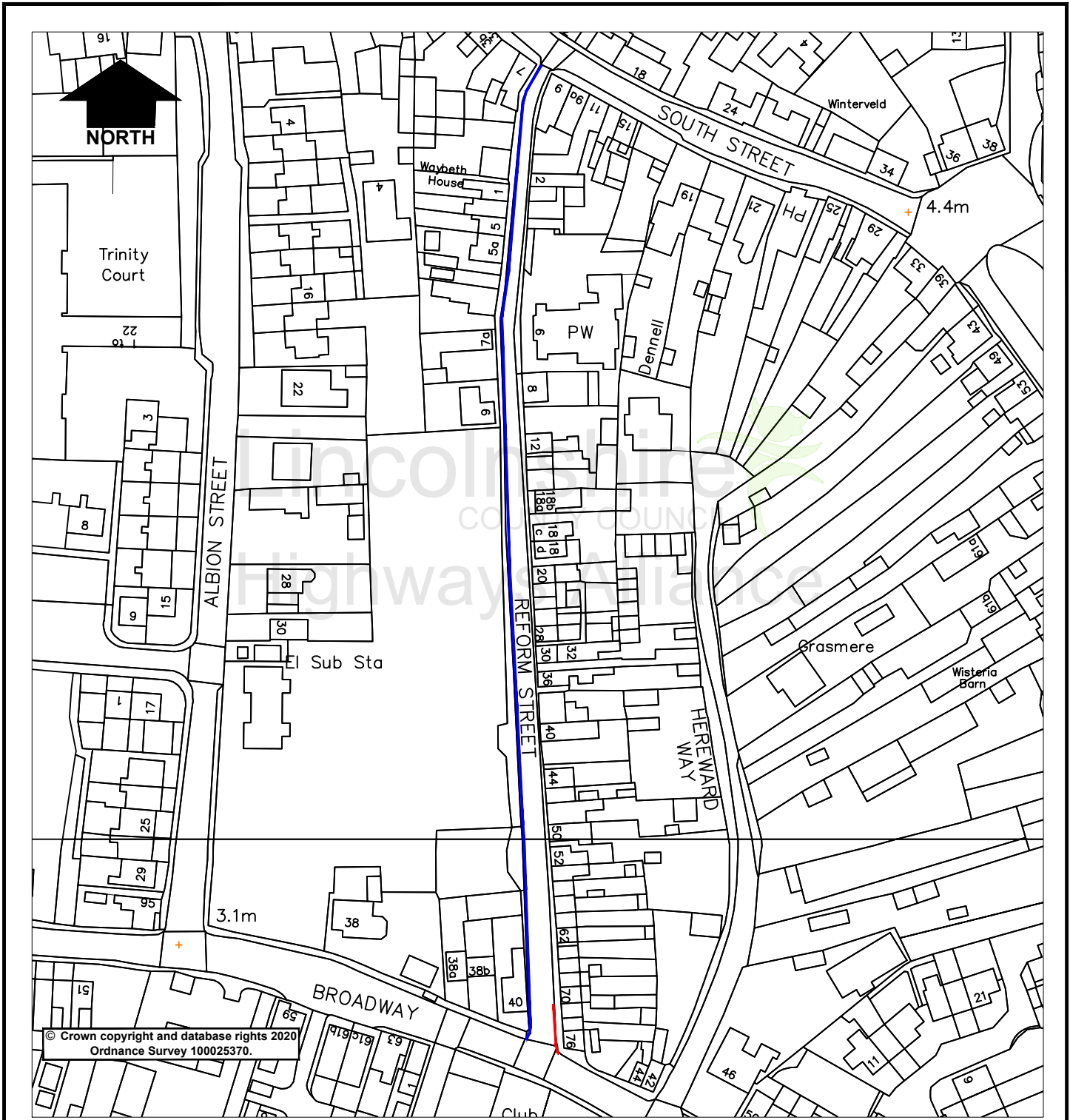
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
