

**LINCOLNSHIRE COUNTY COUNCIL
(STAMFORD – CONDUIT ROAD)
(PROHIBITION OF WAITING) AMENDMENT ORDER 20**

STATEMENT OF REASONS

- Investigations found that there is an increased need for further restrictions to improve visibility in the surrounding area, the proposals will remove any parked vehicles.
- The proposals will facilitate traffic flow, ensure accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, Stamford Town Council and South Kesteven Council have been consulted, along with other local groups/companies.

LINCOLNSHIRE COUNTY COUNCIL (STAMFORD – CONDUIT ROAD) (PROHIBITION OF WAITING) AMENDMENT ORDER 20

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at the below locations:

- Remove the existing parking bay '8am – 6pm Permit holders or 2 hours – No return within 1 hour' outside numbers 34, 43 and 60.
- Install 'No Waiting at Any Time' restrictions outside numbers 43 and 60.
- Install 'No Waiting between 8am and 6pm' outside number 58 and 34.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
