

**LINCOLNSHIRE COUNTY COUNCIL

STATEMENT OF REASONS

- Concerns have been expressed with regards to parking in the vicinity of the school.
- Vehicles have regularly been observed parking inconsiderately resulting in difficulties for all road users and raising safety concerns.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Lincoln City Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce.

- Mandatory School Keep Clear Mon- Friday 8am to 4pm adjacent to the school
- No Waiting Mon- Friday 8am to 4pm at the end of the Francis Street

Exemptions are included on the No Waiting that will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
