Having given due regard to the appropriate local and national planning policy guidance (in particular the National Planning Policy Framework), Lincolnshire County Council (as Highway Authority and Lead Local Flood Authority) has concluded that the proposed development would not be expected to have an unacceptable impact upon highway safety or a severe residual cumulative impact upon the local highway network or increase surface water flood risk and therefore does not wish to object to this planning application.

Comments:

The application is for change of use from touring caravan site to open air swimming lake, erection of changing rooms and sauna with parking and the installation of solar panels which is located within the established site of Watermill Leisure Park

Introduction/Site Location

The site is accessed from Station Road which is suitable to accommodate the proposals.

Existing Conditions

The site has a suitable access to accommodate any vehicle increase for the proposals

The dimensions of the existing access are adequate to enable 2 cars to pass in opposing directions and the proposal would therefore not result in an unacceptable impact on highway safety.

Highway safety

There are no highway safety issues concerned with the proposals

Highway capacity

The proposals are unlikely to generate a significant increase in highway traffic

Site Layout

The site has a sufficient internal layout to ensure vehicles can access and egress the site in a forward gear

Flood Risk and Drainage

As Lead Local Flood Authority, Lincolnshire County Council is required to provide a statutory planning consultation response with regard to Drainage on all Major Applications. This application will not have an unacceptable impact on surface water drainage and will not significantly increase the impermeable areas of the site. Therefore the Lead Local Flood Authority does not consider that this proposal would increase flood risk in the immediate vicinity of the site.
