

**LINCOLNSHIRE COUNTY COUNCIL
(NORTH HYKEHAM – GRACE AVENUE)
(PROHIBITION OF WAITING) AMENDMENT ORDER 20**

STATEMENT OF REASONS

- Lincolnshire County Council recently reviewed the waiting restrictions at the above location.
- The existing waiting restrictions were in place to prevent factory workers from parking on Grace Avenue, as the factory is no longer present a change to the waiting restrictions is now appropriate.
- The limited waiting restriction will be removed along Grace Avenue with the exception of the junction which is proposed to be no waiting at all times to maintain visibility and safety at the junction.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, North Hykeham Town Council and North Kesteven District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to remove the existing No Waiting Monday to Saturday, 8am to 6pm on Grace Avenue and to install No Waiting at Any Time at the Grace Avenue/Station Road junction.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
