STATEMENT OF REASONS

- Investigations have taken place at the location above with a view to providing limited waiting in the area.

- Investigations have shown that inconsiderate parking close to the junctions leads to poor visibility for road users. The proposed restrictions will improve visibility traffic flow and highway safety in the area.

- Therefore, in accordance with the County Council's Policy, it is proposed to introduce limited waiting as per the consultation plan.

- The Chief Constable, Mablethorpe and Sutton on Sea Parish Council and East Lindsey District Council have been consulted, along with other local groups/companies.

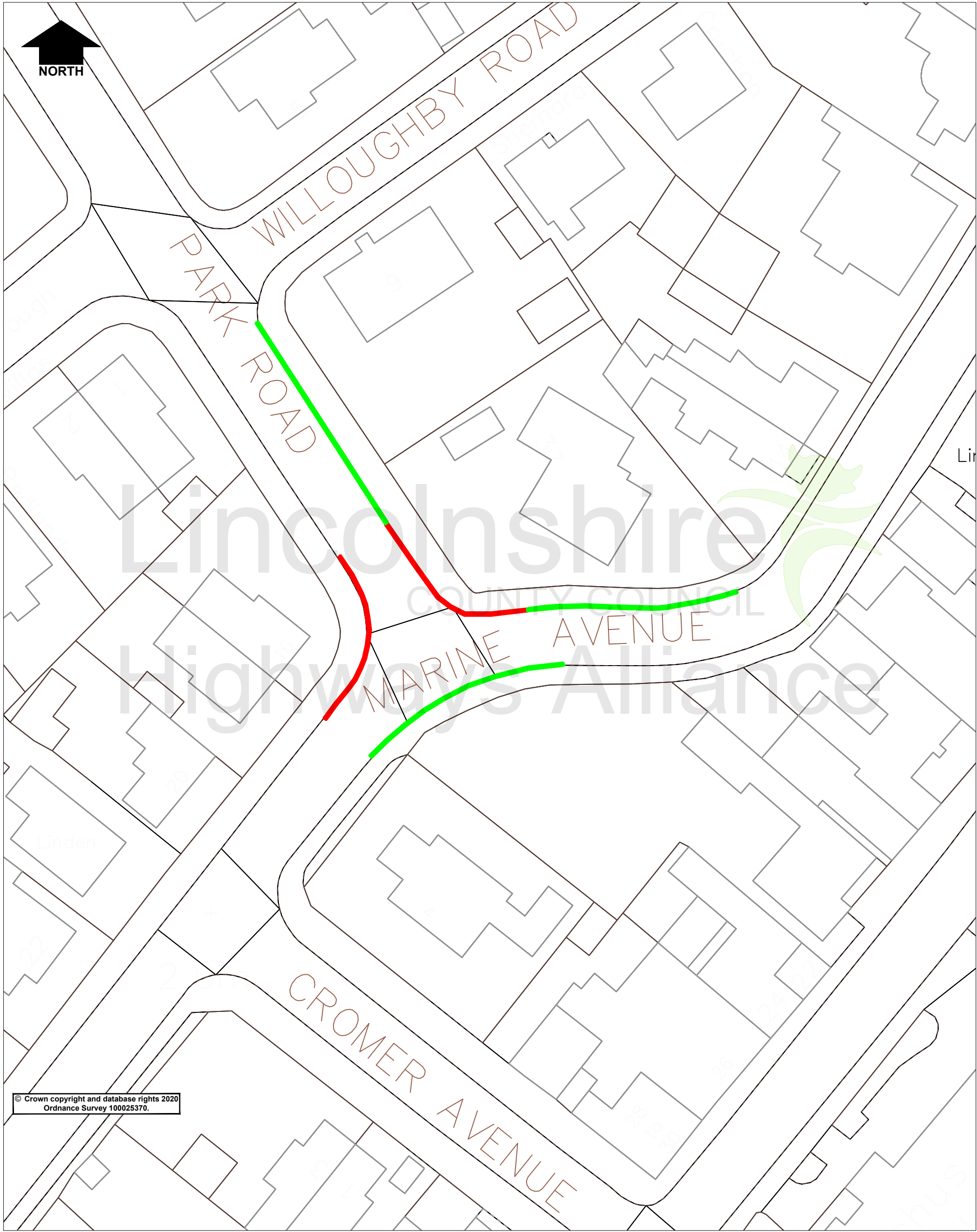
NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce no waiting at any time on the junction of Marine Avenue and Park Road Sutton on Sea.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.



