

ROAD TRAFFIC REGULATION ACT 1984
LINCOLNSHIRE COUNTY COUNCIL
(NORTH HYKEHAM – WESTMINSTER ROAD)
(PROHIBITION OF WAITING) AMENDMENT ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on _____ 20__ and may be cited as the Lincolnshire County Council (North Hykeham – Westminster Road) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Lincolnshire County Council recently reviewed the waiting restrictions at the above location.
- Investigations have shown that despite the current waiting restrictions, parking occurs in an ad hoc, unmanaged manner resulting in some difficulties manoeuvring around parked vehicles.
- In order to allow some parking to take place and to facilitate vehicle movements, it is proposed to prohibit waiting on the north side of Westminster Road and to remove the restrictions on the south side of the road, bar a small section that will be restricted to ensure vehicles can access the northern spur and to allow vehicles to pull in when met with oncoming traffic.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, North Hykeham Town Council and North Kesteven District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to remove the existing No Waiting Monday to Saturday, 8am to 6pm on the majority of the southern side of Westminster Road. The northern side of Westminster Road will become No Waiting at Any Time with small sections of No Waiting at Any Time also on the southern side and at the turning head.

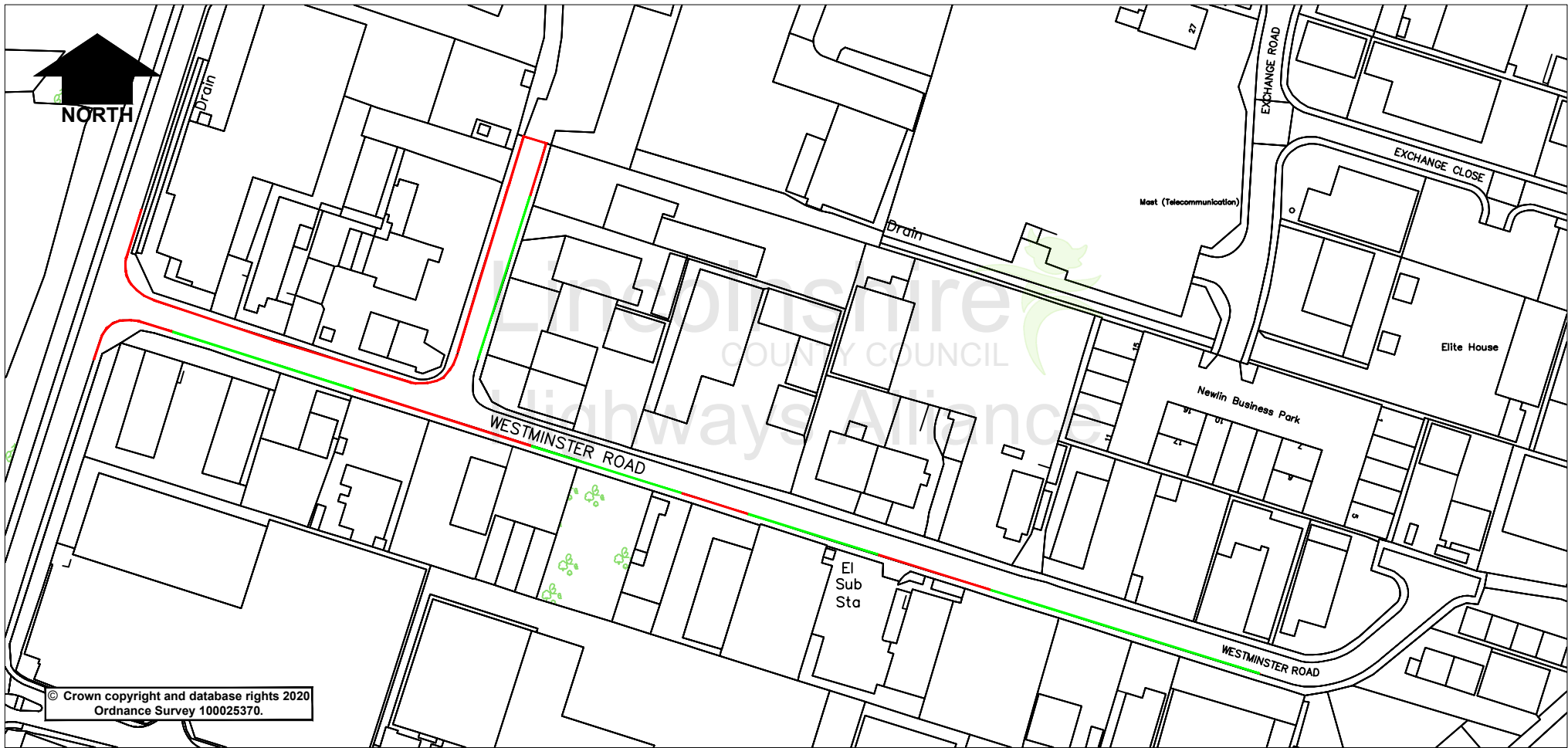
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
