   Plans including the key (the 'Plans') are incorporated into this Order.
- Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
- 4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

### **STATEMENT OF REASONS**

- Lincolnshire County Council recently received a request to review the above location following access difficulties experienced by Stagecoach.
- Assessments have shown that the narrowness of the carriageway when combined with parked vehicles leads to the local bus service being unable to safely navigate Manor Lane without the risk of damage to property or parked vehicles.
- In order to facilitate the passage of this vital service, it is proposed to introduce waiting restrictions. It is acknowledged that some parking for local services and residents will be displaced, however, unrestricted parking is available close by with some services providing their own private car park facilities.
- Waiting restrictions are also proposed on Lincoln Road to ensure good visibility is maintained at both crossing points with the existing bus stop to become a bus stop clearway.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Welton Parish Council and West Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting on the majority of Manor Lane and also on Lincoln Road between Cliff Road and Manor Lane. A Bus Stop Clearway will be established on Lincoln Road.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
