LINCOLNSHIRE COUNTY COUNCIL (MARKET RASEN – MILL ROAD) (PROHIBITION OF WAITING) AMENDMENT ORDER 20

STATEMENT OF REASONS

- Vehicles have regularly been observed parking inconsiderately resulting in difficulties for all road users and raising safety concerns around the School, Library and Health Centre.
- Following investigations at the abovementioned location it was also found that during peak school drop off/pick up times there are vehicles parked/waiting on the advisory 'School Keep Clear' markings.
- The introduction of a formal Traffic Regulation Order will discourage parking/waiting on the 'School Keep Clear' markings and enable civil parking enforcement officers to issue Penalty Charge Notices where appropriate.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, Market Rasen Town Council and West Lindsey District Council have been consulted, along with other local groups/companies.

- Introduce Mandatory School Keep Clear Mon-Fri 8am-5pm in front of the school.
- Revoke existing No Waiting Mon-Fri 8am-5pm fronting the school.


