(PROHIBITION OF WAITING) AMENDMENT ORDER 2024

STATEMENT OF REASONS

- Concerns have been expressed with regards to parking in the vicinity of the school.
- Vehicles have regularly been observed parking inconsiderately resulting in difficulties for all road users and raising safety concerns.
- Following investigations at the above mentioned location it was found that during peak school drop off/pick up times there are vehicles parked/waiting on the advisory 'School Keep Clear' markings.
- The introduction of a formal Traffic Regulation Order will discourage parking/waiting on the 'School Keep Clear' markings and enable civil parking enforcement officers to issue Penalty Charge Notices where appropriate.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, Old Leake Parish Council and Boston Borough Council have been consulted, along with other local groups/companies.

- Introduce Mandatory School Keep Clear Mon-Fri 8am-9.30am and 2.30pm-4.30pm at both school entrances on Church Road.
- Introduce No Waiting at Any Time at junctions of Meadow Way and Church Road, Old Main Road and Church Road and junction of A52 and Church Road.
- Introduce No Waiting at Any Time opposite numbers 19 & 21 Church Road.
- Introduce Bus Stop Clearways Mon-Sat 5am-8pm on four existing bus stops on Church Road

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
