

LINCOLNSHIRE COUNTY COUNCIL
(LINCOLN – BURTON ROAD)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2024

STATEMENT OF REASONS

- Investigations have shown that buses cannot access the bus stop outside of the Methodist Church and limited waiting bay outside properties 78 and 80 is causing an obstruction and restricting traffic flow.
- The proposals will remove obstruction of the highway by parked vehicles, facilitate traffic flow and improve visibility and road safety for all users.
- The limited waiting bay that will be removed outside properties 78 and 80 will be re-located outside Cliff Court so there is no loss off on street parking. We will also be extending the existing limited waiting bay outside the surgery to allow another parking space.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, City of Lincoln Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting as set out in the Schedule below:

- Introduce a Bus Stop Clearway 7am-7pm outside the Methodist Church
- Extend the existing limited waiting Mon-Sat 8am-6pm, No return within 2 hours outside the Surgery
- Introduce limited waiting Mon-Sat 8am-6pm, No return within 2 hours outside Cliff Court.

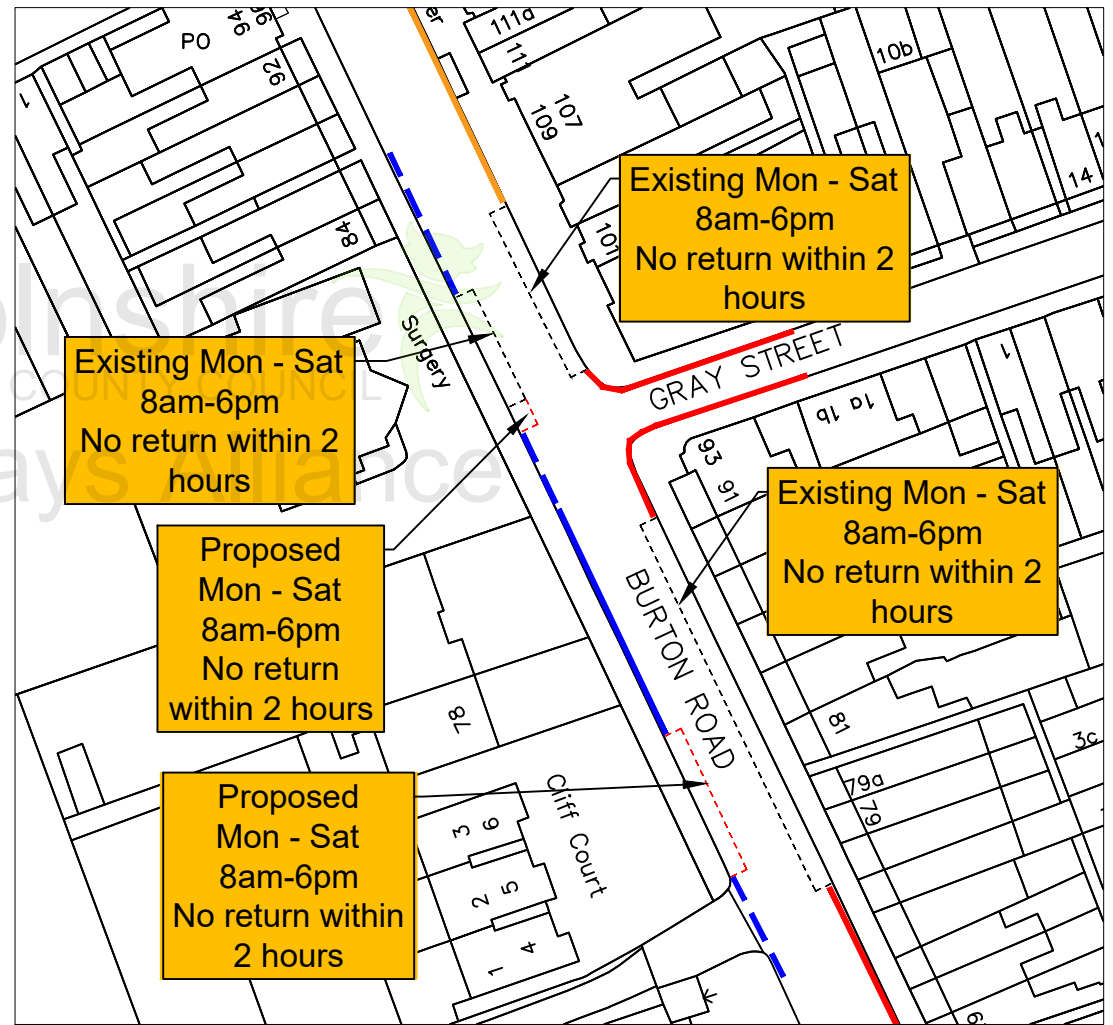
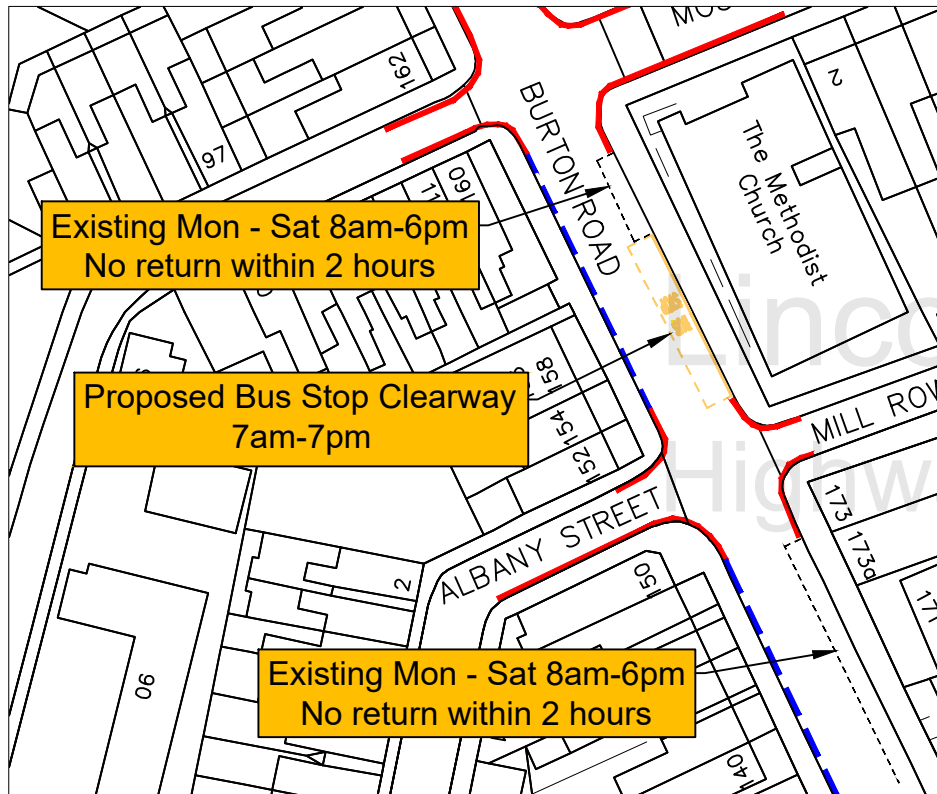
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
