Highway and Lead Local Flood Authority Report

Substantive Response provided in accordance with article 22(5) of The Town and Country Planning (Development Management Procedure) (England) Order 2015:

Recommendation: Approve with conditions

This proposal is for the change of use of land for use as a touring caravan site, erection of an amenity block and construction of internal access roads to provide 56no. new holiday touring caravan pitches. The proposed development will utilise the existing access from Wainfleet Road which serves the current use and meets the guidelines set out in Manual for Streets for visibility. Adequate provision for car parking and turning space has been provided within the limits of the site to enable vehicles to enter and leave in a forward gear and therefore, it is considered that this proposal would not result in an unacceptable impact upon highway safety. Additional vehicles movements on average are likely to be limited and it is unlikely that all visitors will arrive and depart at the same time.

As Lead Local Flood Authority, Lincolnshire County Council is required to provide a statutory planning consultation response with regard to Drainage on all Major Applications. For this application, the roof water from the toilet/shower block will be discharged to soakaways. The rainfall run-off from the roof of the touring caravans will discharge to ground like any other caravan. The new roadways will be constructed with open textured tarmac on a 250mm layer of 6F2 hardcore to provide a sustainable and permeable roadway and not increasing green field runoff rates to watercourses and will mimic the current regime. Therefore the Lead Local Flood Authority does not consider that this proposal would increase flood risk in the immediate vicinity of the site.

Highway Condition 21

No part of the development hereby permitted shall be occupied before the works to improve the public highway have been certified complete by the Local Planning Authority. The works required are as follows:-

- The upgrading of the pedestrian crossing at the existing access to the development site with tactile paving
- The upgrading of the Queen Road junction pedestrian crossing with tactile paving (76 metres from site) and the Burlington Road junction pedestrian crossing with tactile paving too (149 metres from site).

Reason: To ensure the provision of safe and adequate means of access to the permitted development.

The highway improvement works referred to in the above condition are required to be carried out by means of a legal agreement between the landowner and the County Council, as the Local Highway Authority.
