

**ROAD TRAFFIC REGULATION ACT 1984**

**LINCOLNSHIRE COUNTY COUNCIL**

**(BOSTON – ASHTON HALL DRIVE)**

**(PROHIBITION OF WAITING) AMENDMENT ORDER 20**

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on \_\_\_\_\_ 20\_\_\_\_ and may be cited as the Lincolnshire County Council (Boston – Ashton Hall Drive) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

**STATEMENT OF REASONS**

- Lincolnshire County Council recently received a request to review the waiting restrictions at the above location.
- Investigations have shown that parking from the nearby industrial units is occurring in the residential area on the narrower section of estate road. This parking is leading to damage to the verges where residents are forced to overrun the verge in order to access driveways.
- The aim of the proposal is to encourage parking to take place within the units themselves or on Gilbert Drive, adjacent to Ashton Hall Drive where the road is industrial in nature therefore wider and better able to accommodate parking.
- Therefore, in accordance with the County Council's Policy, it is proposed to introduce limited waiting as per the consultation plan.
- The Chief Constable and Boston Borough Council have been consulted, along with other local groups/companies.

On the northern side of Ashton Hall Drive in the vicinity of the roundabout/car dealership

At the junction of Ashton Hall Drive/Mentmore Gardens

At the junction of Ashton Hall Drive/Rothschild Close

At the junction of Ashton Hall Drive/Bayford Green

### **No Waiting 8am to 6pm, Mon to Fri**

On both sides of Ashton Hall Drive between numbers 2 and 50

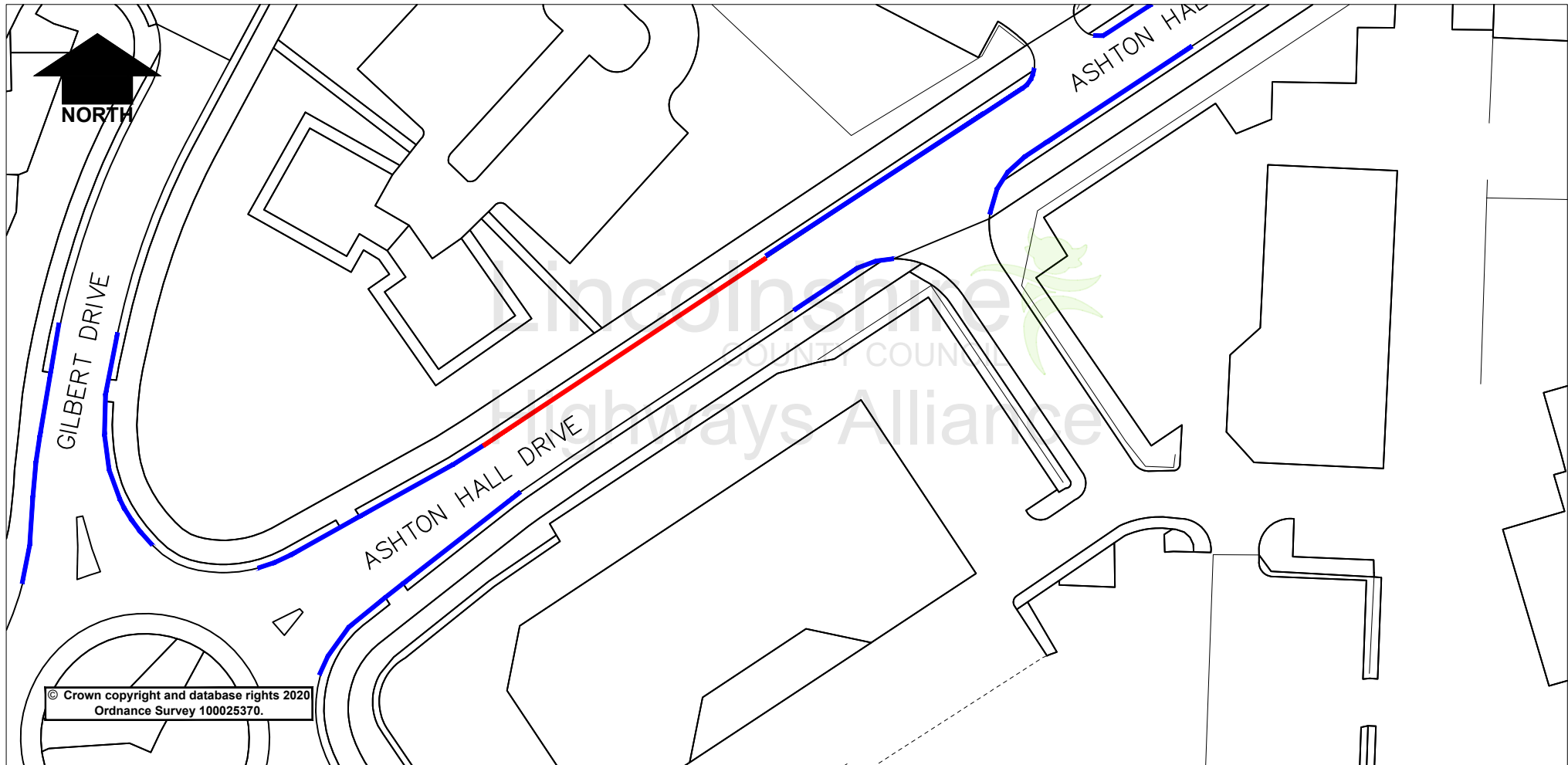
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
