Having given due regard to the appropriate local and national planning policy guidance (in particular the National Planning Policy Framework), Lincolnshire County Council (as Highway Authority and Lead Local Flood Authority) has concluded that the proposed development would not be expected to have an unacceptable impact upon highway safety or a severe residual cumulative impact upon the local highway network or increase surface water flood risk and therefore does not wish to object to this planning application.

Comments:


The proposal is to use land for a holiday caravan park.

The land is currently a caravan park, and the proposal seeks to ensure the permission is enured to the land and not to the individual operator. The site is situated in a sustainable area with convenient access to nearby shops and services, both locally and in the surrounding region, and is near various sustainable transportation options.

The development proposals will generate a comparable amount of trips. It is therefore not be possible to raise an objection to the proposals based on traffic impact, in accordance with the NPPF.

The dimensions of the existing access are adequate to enable two cars to pass in opposing directions and the proposal would therefore not result in an unacceptable impact on highway safety.

There is no change to layout; the Public Footpath is not affected on ground by proposal, but attention is drawn to the route of the Public Footpath through the site as shown below on the Definitive Map. This must be open and available for use at all times.



As Lead Local Flood Authority, Lincolnshire County Council is required to provide a statutory planning consultation response with regard to Drainage on all Major Applications. This application site lies within flood zone 3, protected by flood risk defenses at Ingoldmells seafront. Access to the site is along the southern boundary from Sea Lane. The proposals will use the current drainage system on-site, with no planned changes to the system or the volume of surface and foul water entering it. Therefore, the Lead Local Flood Authority does not consider that this proposal would increase flood risk in the immediate vicinity of the site.
