STATEMENT OF REASONS

- Investigations have taken place at the location above with a view to providing waiting restrictions in the area.
- Investigations have shown that the junction is narrow and parking close to the junction leads to poor visibility for all road users. The proposed restrictions will improve visibility and traffic flow in the area for all road users.
- The Chief Constable, Grantham Town Council and South Kesteven District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting on the junction of Twyford Gardens and New Beacon Road.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.

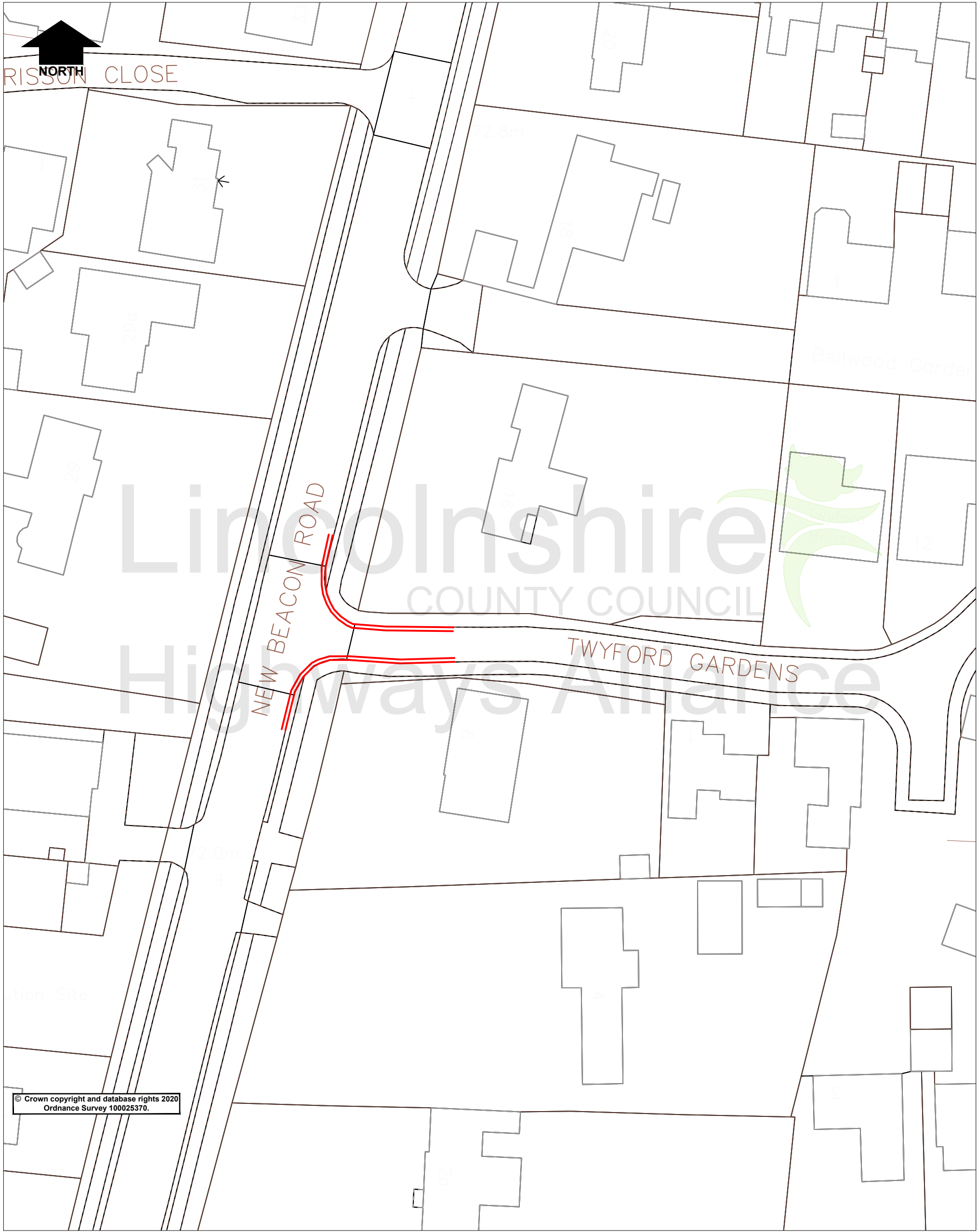
