

**ROAD TRAFFIC REGULATION ACT 1984**

**(PROHIBITION OF WAITING) AMENDMENT ORDER 20**

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on \_\_\_\_\_ 20\_\_ and may be cited as the Lincolnshire County Council (Butterwick - School Lane, Butterwick Road & Girls School Lane) (Prohibition of Waiting) Amendment Order 20\_\_
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

**STATEMENT OF REASONS**

- Investigations have taken place at the location above with a view to providing waiting restrictions in the area.
  
- Investigations have shown that the advisory School Safety Zone is often not adhered to, with parking on both sides of the carriageway causing visibility issues that leads to conflict with oncoming traffic. Inconsiderate and dangerous parking is also occurring on the bus stops on School Lane, at the junctions of Pinchbeck Road, Girls School Lane, Butterwick Road and beyond the 30mph speed limit, causing safety concerns for all road users.  
The proposed restrictions will facilitate traffic flow and maintain good visibility in the interest of highway safety.
  
- Therefore, in accordance with the County Council's Policy, it is proposed to introduce limited waiting as per the consultation plan.
  
- The Chief Constable, Butterwick and Freiston Parish Council and Boston Borough Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce.

- No Waiting at Any Time on the junctions of Pinchbeck Road and Girls School Lane
- Mandatory school keep clear markings in the vicinity of the school Mon – Fri 8am – 9.30am and 2.30pm - 4pm.
- No Waiting Mon – Fri 8am – 9.30am and 2.30pm - 4pm on the south side of Butterwick Road
- Bus Stop Clearways - The clearway will ensure unrestricted access for scheduled bus services by prohibiting the stopping, waiting and loading of any vehicle except a bus. The clearways will be in operation between the hours of 6.30am to 8pm Monday to Saturday.
- Extend the existing 30mph and introduce a 40mph speed limit on Butterwick Road

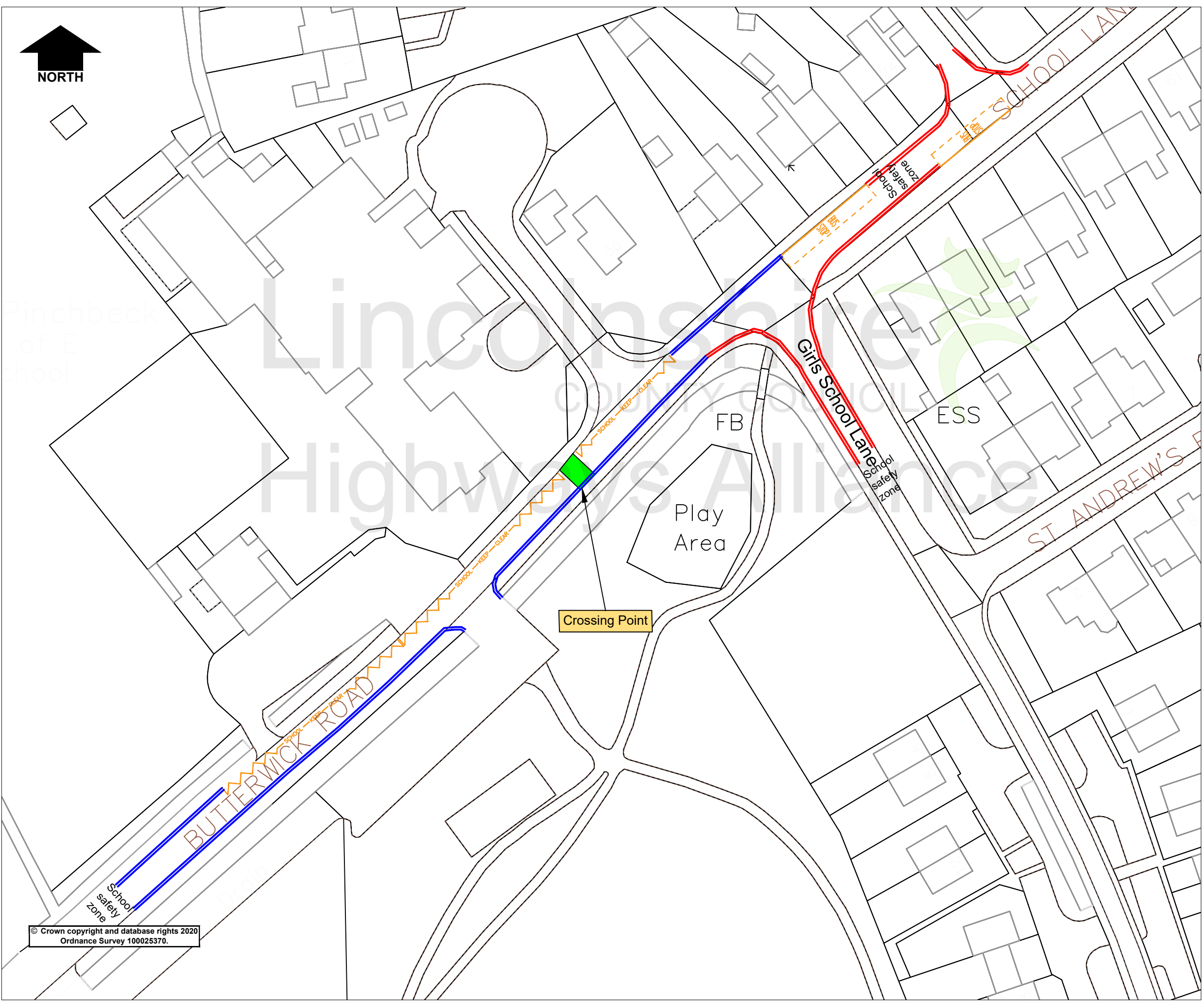
Exemptions are included on the no waiting restrictions which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
