STATEMENT OF REASONS

- Following investigations at the above mentioned location it was found that the existing H-bar and residents parking bay arrangement is causing access issues for residents.
- The proposals will remove obstruction of the highway by parked vehicles and ensure all accesses are kept clear.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, City of Lincoln Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce no waiting at any time which will replace the existing h bars covering accesses outside Cecil Mews, Mary Sookias House and between properties 26-28 and 30A-32.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
