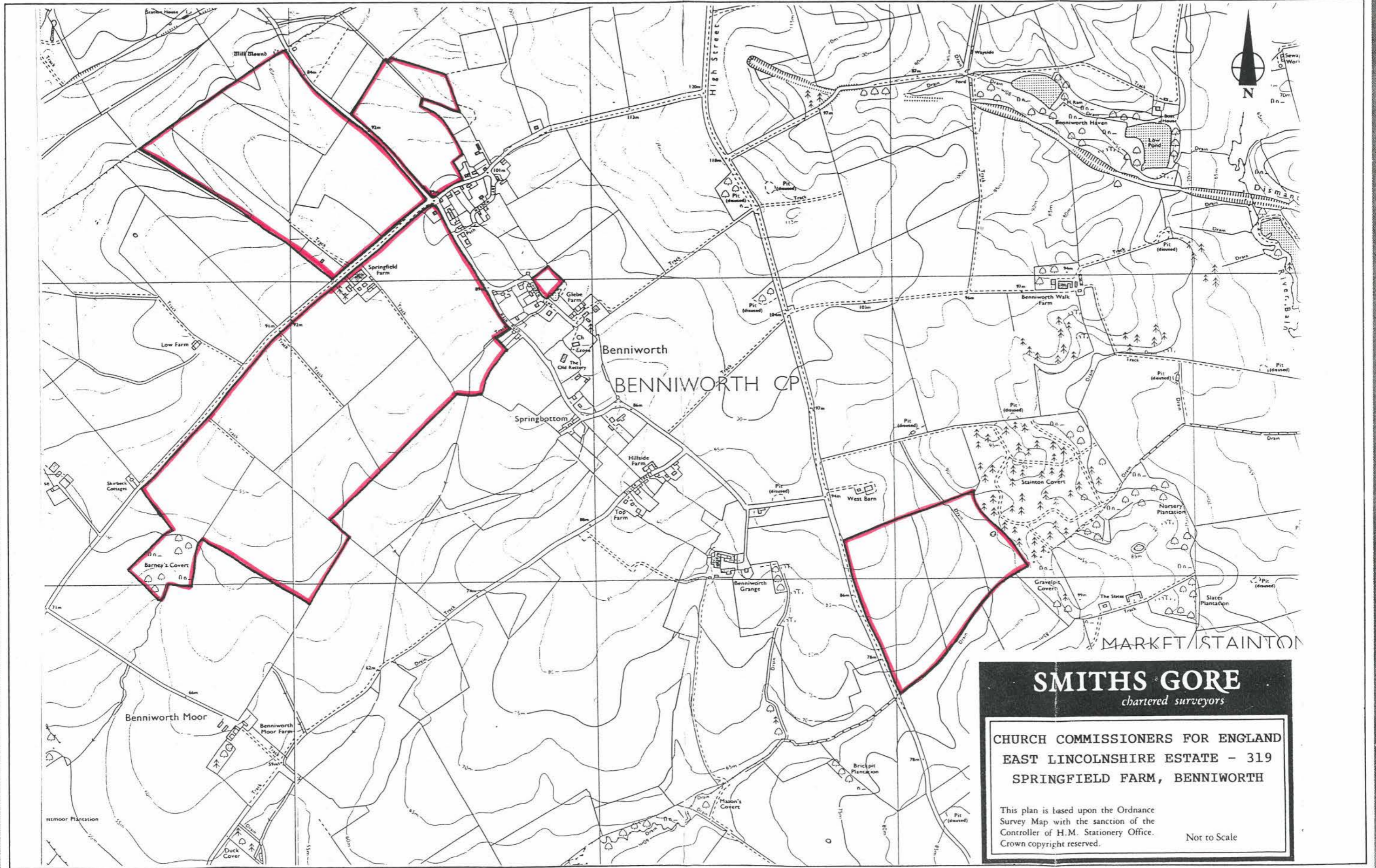

Statutory Declaration pursuant to section 31(6) Highways Act 1980

I, **JAMES ROBERT MARKBY HOWE**, the Rural Assets Manager of the Church Commissioners for England ("the Commissioners") DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Commissioners are the owners within the meaning of the above section of the land known as Springfield Farm, Benniworth more particularly delineated and shown edged red and shaded yellow on the plan accompanying this declaration ("the Property").
2. On the 28th day of October 2005 I deposited with Lincolnshire County Council, being the appropriate council, a statement accompanied by a plan delineating the Property by red edging which stated that no ways had been dedicated over the Property
3. No additional ways have been dedicated over the Property since the statement dated 28th October 2005 referred to in 2 above and at the present time the Commissioners have no intention of dedicating any more public rights of way over the Property.
