**STATEMENT OF REASONS**

- Due to the new development on Cross Spencer Street it has been identified that larger vehicles will not be able to access the site safely due to parked vehicles. It is proposed to introduce no waiting at any time at the junction of the development and on Spencer Street.
- The proposals will remove any parked vehicles and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable, City of Lincoln Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to extend the existing no waiting at any time on Cross Spencer Street and introduce no waiting at any time on Spencer Street outside properties 8-10.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
