

ROAD TRAFFIC REGULATION ACT 1984

(PROHIBITION OF WAITING) AMENDMENT ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 20 and may be cited as the Lincolnshire County Council (Gainsborough – Market Place) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of their powers under Sections 1(1), 2(1) and (2) and 3(2) Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. This Order shall come into operation on _____ 20 ____ and may be cited as the Lincolnshire County Council (Gainsborough – Market Place, Silver Street & Flag Alley) (Prohibition of Driving) Order 20
2. Save as provided in Article 4 no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any motor vehicle to enter or proceed on any road or length of road specified in Schedule 1 to this Order between the hours of 10.00am to 3.00pm.
3. Save as provided in Articles 4 and 5 no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any motor vehicle to enter or proceed on any road or length of road specified in Schedule 1 to this Order between the hours of 3.00pm to midnight and midnight to 10.00am.
4. Nothing in Articles 2 and 3 shall render it unlawful for a person to cause or permit any motor vehicle to enter or proceed on any road or length of road specified in the Schedule, if the vehicle is:-
 - (a) for Police, Fire Brigade or Ambulance purposes;
 - (b) granted special written exemption by Lincolnshire County Council.

- (c) a purpose built or specially adapted security vehicle which by distinctive external markings and/or trade signs may be easily identified as a security vehicle, operated by uniformed security personnel and which is being used for the purpose of delivery or collection of:
 - (i) bullion or
 - (ii) substantial quantities of money in the form of cash or
 - (iii) high value commodities
 - (d) being used to gain access to off street garaging.
 - (e) Other than a privately owned vehicle, any which is being used as an official vehicle for the purpose of a wedding or funeral at a Church or place of worship.
5. Nothing in Article 3 shall render it unlawful for a person to cause or permit any motor vehicle to enter or proceed on any road or length of road specified in the Schedule, if the vehicle is:-
- (a) being used for or in connection with the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that length of road or where access cannot be obtained to premises on adjoining roads by any other public highway;
 - (b) in connection with the carrying out on, or on premises situated on or adjacent to, that length of road of any of the following operations, namely:
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of that length of road;
 - (iv) the laying, erection, alteration or repair in or in land adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Digital Economy Act 2017;
 - (c) in the service of a local authority, water undertaker or sewage undertaker in connection with work being carried out on, or on land adjacent to that length of road in pursuance of statutory powers or duties.

(d) being used for the provision of a local service as defined in section 2 of the Transport Act 2000.

6. No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any motor vehicle to enter or proceed on any road or length of road specified in Schedule 2 to this Order.

7. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

SCHEDULE 1

Prohibition of Driving (Except for Access)

Lord Street

From its junction with Parnell Street in an easterly direction to its junction with Church Street.

Market Place

For its entirety.

Silver Street

From its junction with Market Place in a southerly direction for a distance of 85 metres.

For its entirety.

STATEMENT OF REASONS

- Lincolnshire County Council recently reviewed the current restrictions at the above location in collaboration with West Lindsey District Council.
- The existing restriction on access for traffic within the above areas applies between 10am and 4pm. As part of ongoing improvements in the area and in conjunction with the reinstatement of the rising bollards at the entry points to Lord Street and Market Place, it is proposed to amend the times of this restriction to apply between 10am and 3pm.
- As is the case now, some exemptions will be included in the Order but vehicular access to premises within this area, including for loading and unloading, will be restricted during this period. It is also proposed to introduce a full-time restriction on vehicular access (with no exemptions) along Flag Alley.
- A 24-hour restriction on parking is currently in force on Lord Street and within the Market Place. As part of this scheme, it is proposed to extend this to apply within Flag Alley and around the perimeter of the Market Place to clarify the extent over which it may be enforced.
- Therefore, in accordance with the County Council's Policy, it is proposed to implement new Traffic Regulation Orders.
- The Chief Constable, Gainsborough Town Council and West Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to:

- Prohibit waiting on Market Place
- Prohibit driving at all times on Flag Alley with no exemptions
- Prohibit driving on Lord Street, Market Place and Silver Street between the hours of 10am to 3pm with some exemptions.

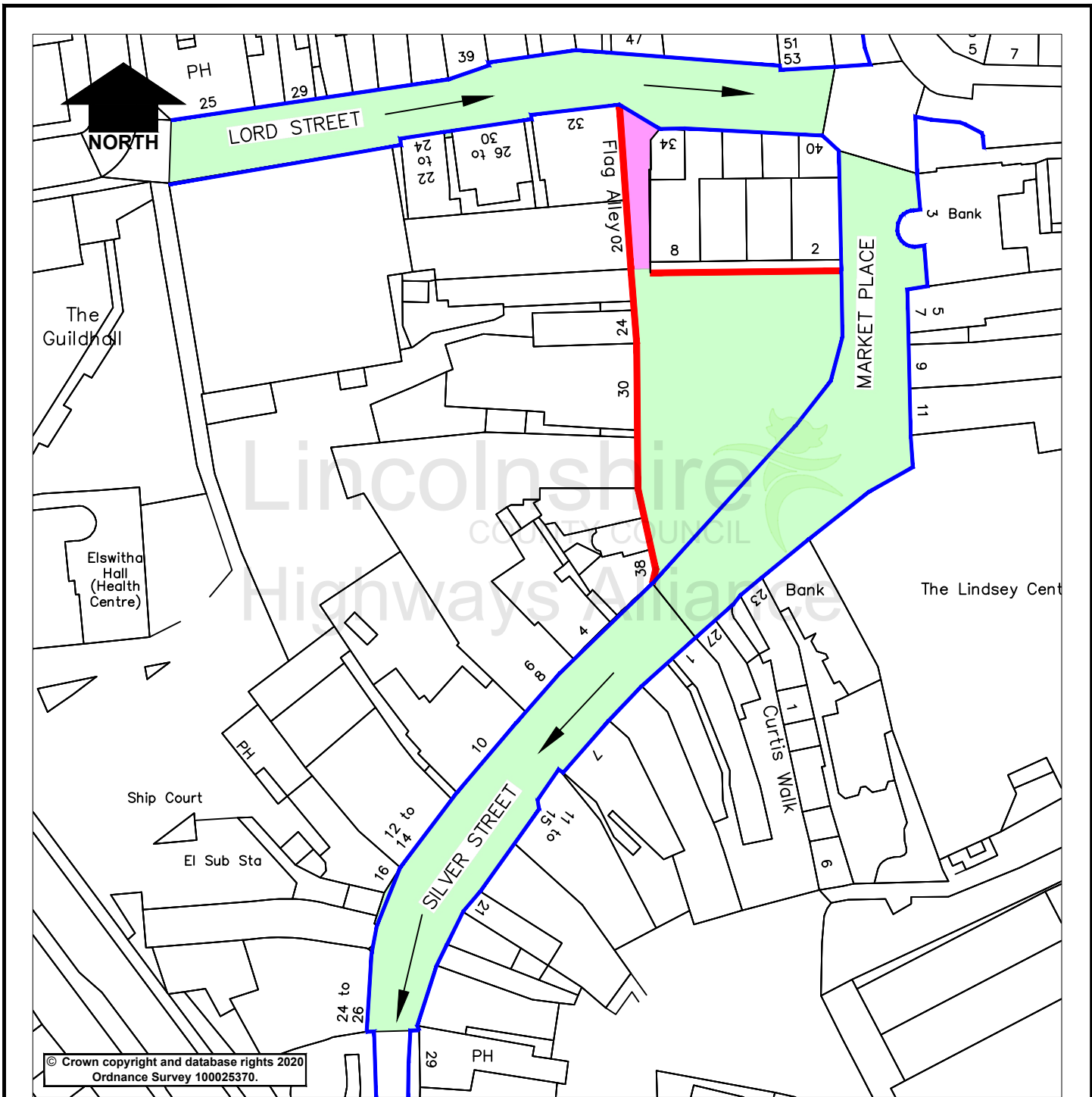
Exemptions are included to some restrictions which will permit the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
