

ROAD TRAFFIC REGULATION ACT 1984
LINCOLNSHIRE COUNTY COUNCIL
(MARSTON & HOUGHAM - VARIOUS ROADS)
(30MPH & 40MPH SPEED LIMIT) ORDER 20

The LINCOLNSHIRE COUNTY COUNCIL in exercise of their powers under Sections 84 (1) and (2) of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the Lincolnshire County Council (Marston & Hougham - Various Roads) (30mph & 40mph Speed Limit) Order 20 and shall come into operation on 20.
2. No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road specified in Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 40mph on the length of road specified in Schedule 2 to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those regulations.

Schedule 1 - 30mph

Bridge Street

From a point 40 metres north west of its junction with Frinkley Lane in a southerly direction for a distance of 300 metres

Frinkley Lane

From its junction with Bridge Street in a south easterly direction for a distance of 50 metres

Schedule 2 - 40mph

Main Street

From a point 40m north west of its junction with Frinkley Lane in a westerly direction for a distance of 342 metres

Brandon Road

From its junction with Main Street in a northerly direction for a distance of 650 metres

Gelston Road

From its junction with Brandon Road in the easterly direction for a distance of 45 metres

STATEMENT OF REASONS

- When comparing the conditions to the current speed limit policy, a 30mph Speed Limit along Bridge Street, Marston and 40mph Speed Limit along Main Street and Brandon Road, Hougham has been justified.
- Therefore, in accordance with the County Council's Policy, it is proposed to introduce a 30mph and 40mph speed limit as per the schedule in the Order.
- The Chief Constable, Hougham and Marston Parish Councils and South Kesteven District Council have been consulted, along with other local groups/companies.

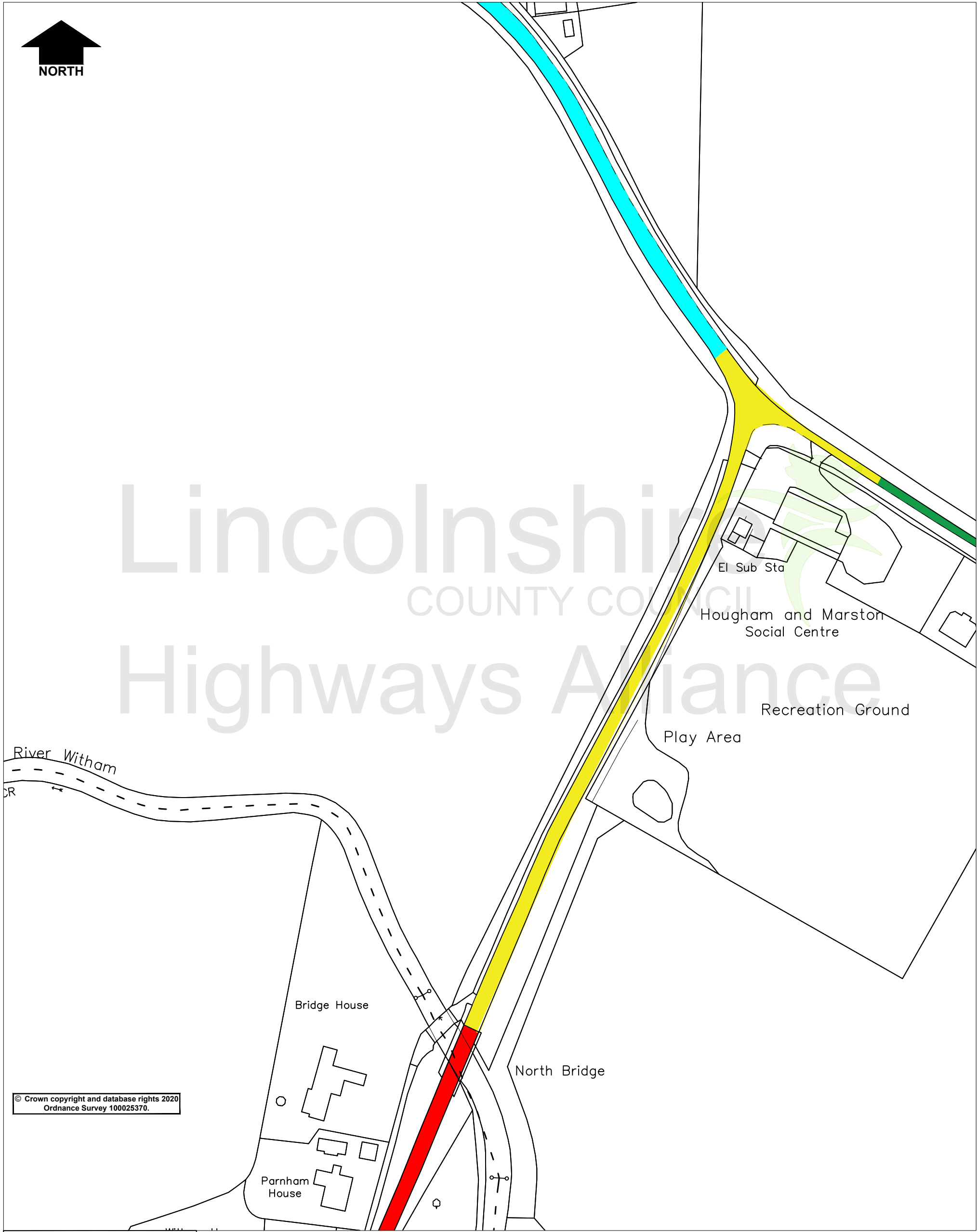

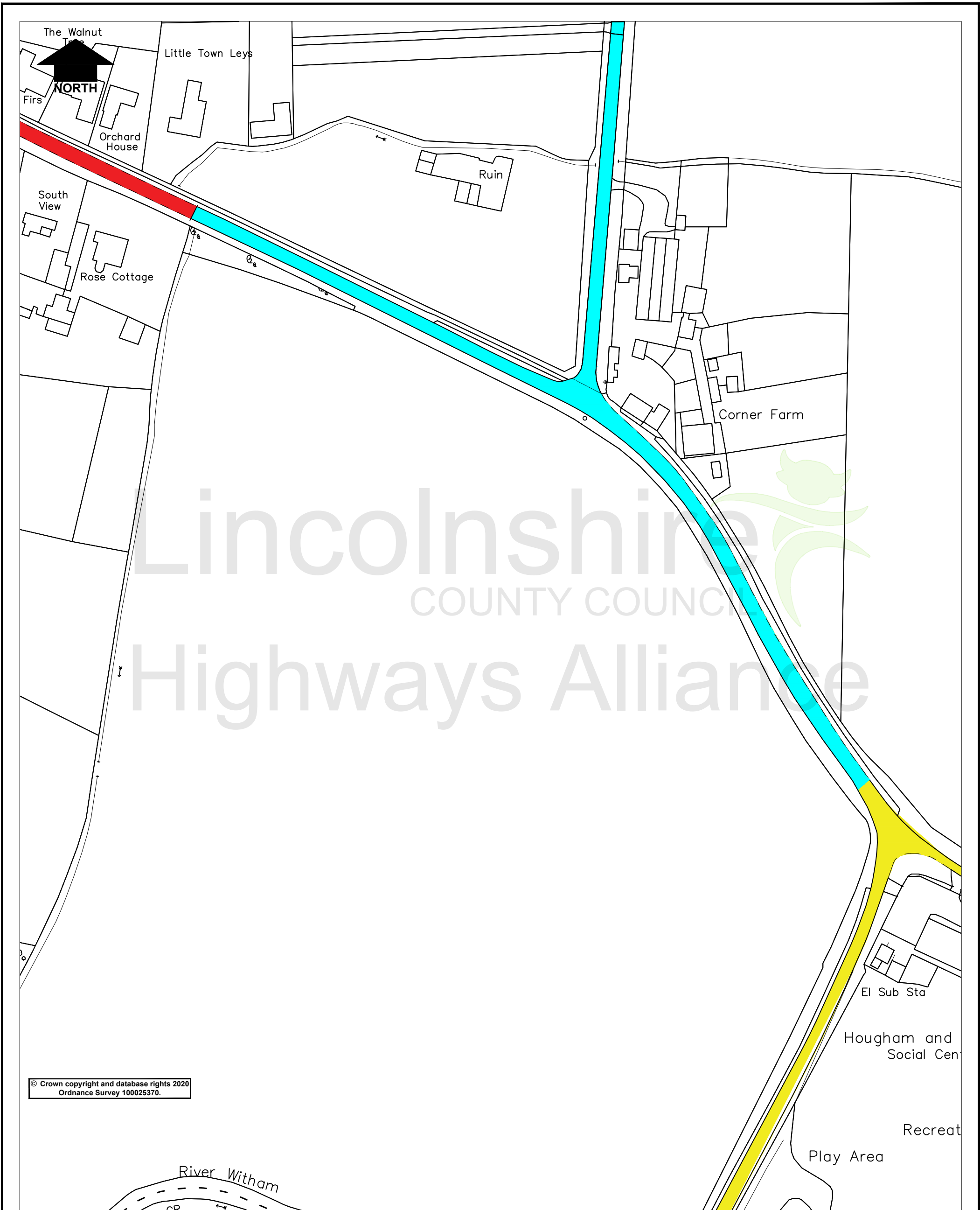

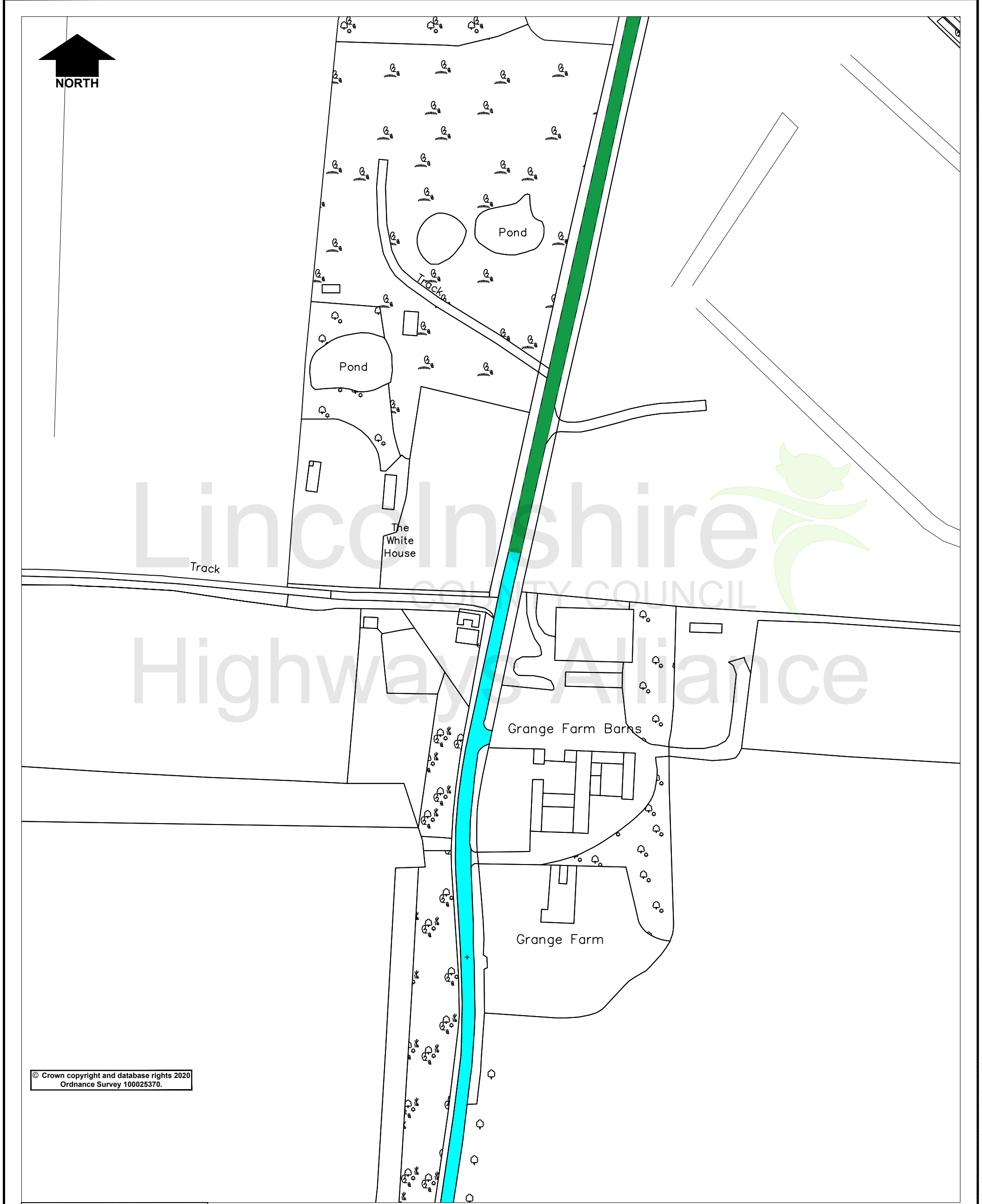
