The effect of the Order as confirmed is to divert the whole width of Public Footpath No.346 in the parish of Sibsey running from an unaffected part of Sibsey Public Footpath No.346 at OSGR TF 3498 5311 (A) in a generally southerly direction for approximately 111m to OSGR TF 3497 5300 (B) then continuing in a generally east south easterly direction for approximately 101m to terminate at the A16 at OSGR TF 3506 5296 (C). The total length of footpath diverted is approximately 212m as shown between points A-B-C on Order drawing number 2024/002/PPO381/A4 TO AN ALTERNATIVE ROUTE in the parish of Sibsey to be 2m wide running from an unaffected part of Sibsey Public Footpath No.346 at OSGR TF 3498 5311 (A) in a generally easterly direction for approximately 99m to terminate at the A16 at OSGR TF 3508 5311 (D). The total length of footpath added is approximately 99m as shown between points A-D on Order drawing number 2024/002/PPO381/A4.

#### **PUBLIC PATH DIVERSION ORDER 2024**


#### Description of site of new path/ way
