

ROAD TRAFFIC REGULATION ACT 1984
LINCOLNSHIRE COUNTY COUNCIL
(SUTTON ON SEA – BROADWAY & YORK ROAD)
(PROHIBITION OF WAITING) AMENDMENT ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53,124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on _____ 20__ and may be cited as the Lincolnshire County Council (Sutton on Sea – Broadway & York Road) (Prohibition of Waiting) Amendment Order 20__
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- In anticipation of resurfacing works and the opening of the Colonnade, Lincolnshire County Council recently reviewed the waiting restrictions at the above location.
- There are currently several non-enforceable H-Bars within the limited waiting bays. Some of these H-Bars can be removed, with some requiring a formal restriction to maintain access to property. These will be replaced with a No Waiting at Any Time restriction.
- A No Waiting at Any Time restriction is proposed at the junction with the A52 to maintain visibility in the vicinity of the co-op car park and at the junction with Broadway and Furlongs Road/York Road.
- The current seasonal limited waiting bays will be replaced with a year-round limited waiting restriction, 1 hour limited waiting, 8am to 6pm, no return within 1 hour, in line with the High Street to allow for a turnover of vehicles wishing to use the local facilities.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Sutton on Sea Parish Council and East Lindsey District Council have been consulted, along with other local groups/companies.

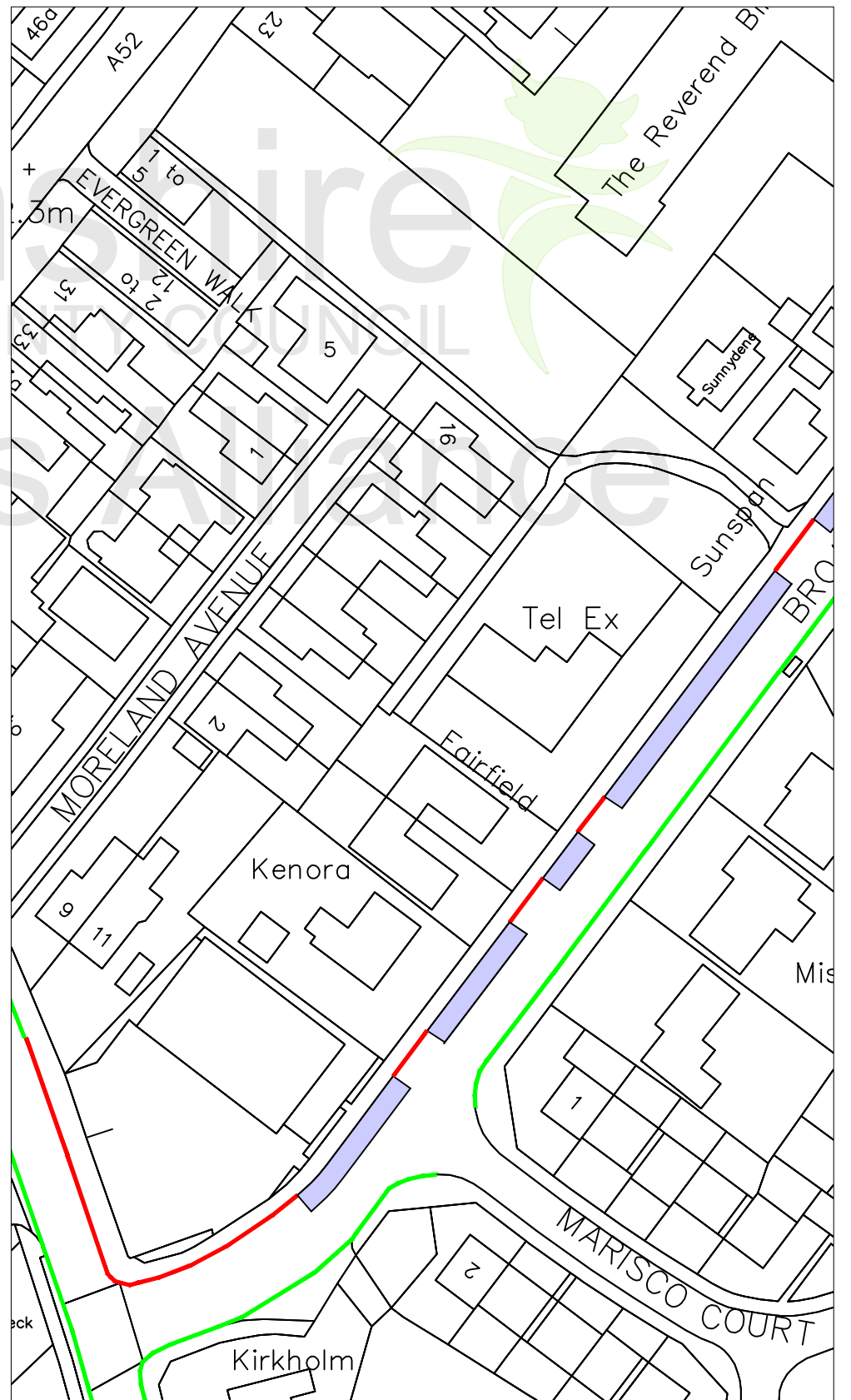
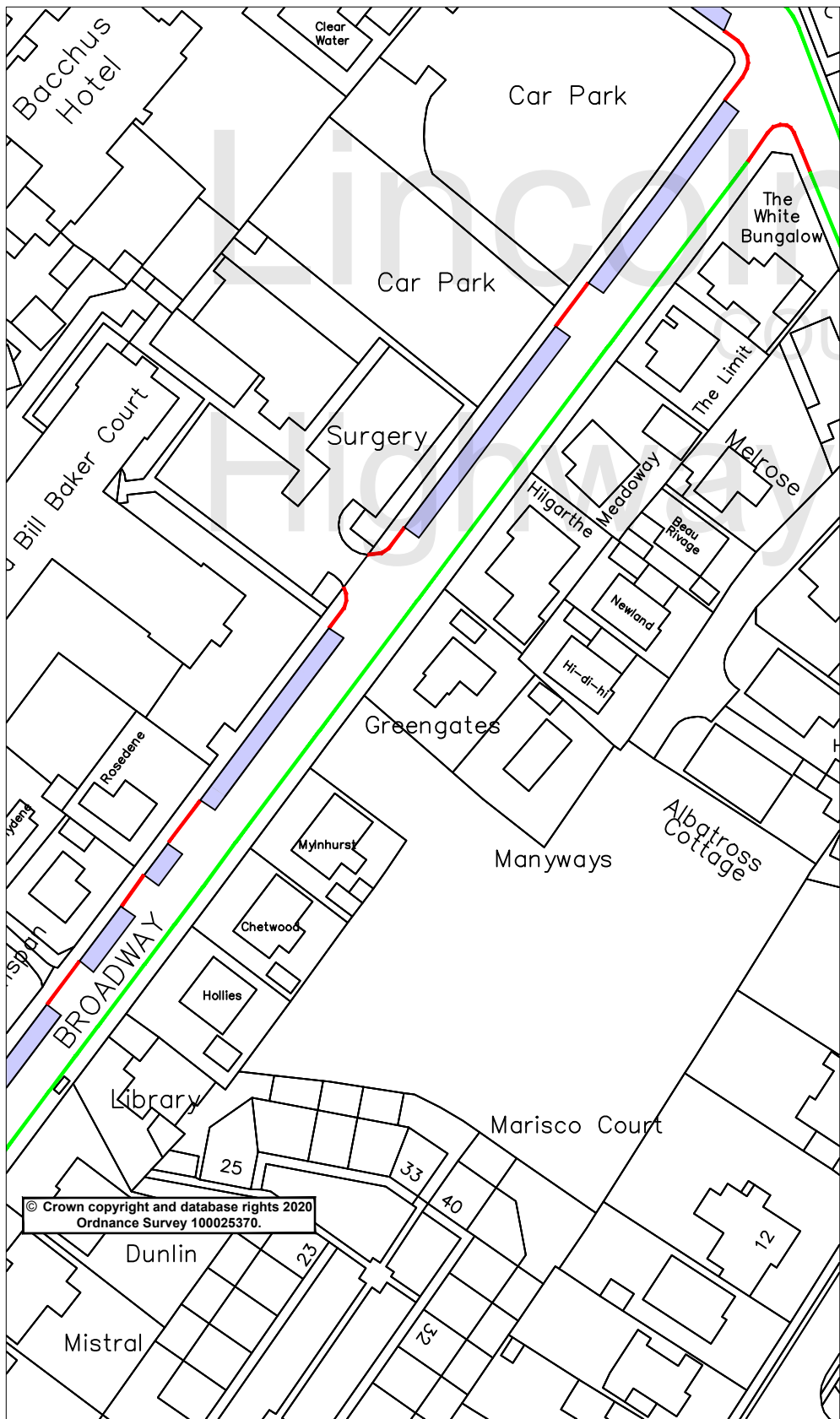
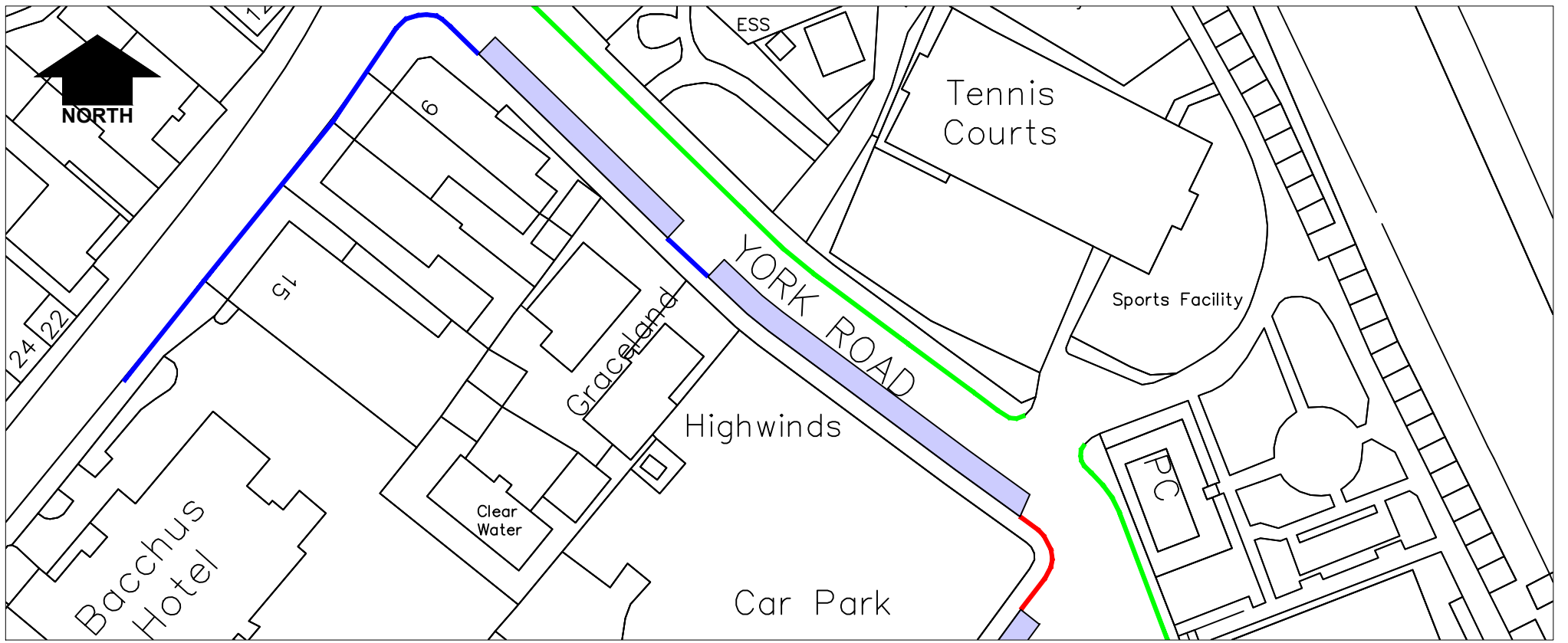
NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to change the existing parking bay times on Broadway and York Road, to an all year-round restriction allowing parking for 1 hour, no return within 1 hour, 8am to 6pm. H-Bars that currently protect dropped kerb accesses will be replaced with No Waiting at Any Time. No Waiting at Any Time is also proposed at the junction of York Road/Broadway and in the vicinity of the Co-op.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
