

NOTICE OF PUBLIC PATH ORDER
HIGHWAYS ACT 1980
LINCOLNSHIRE COUNTY COUNCIL
PART OF PUBLIC FOOTPATH NUMBER 6 CROWLAND
PUBLIC PATH DIVERSION ORDER 2024

The above Order, made on 5 December 2024 under Section 119 of the Highways Act 1980 will divert the whole width of Public Footpath No.6 in the parish of Crowland running from Crowland Public Footpath No.6 at OSGR TF 2104 1231 (A) in a generally west south westerly direction for approximately 209m to terminate at an unaffected part of Crowland Public Footpath No. 6 at OSGR TF 2085 1222 (B). The total length of footpath diverted is approximately 209m as shown between points A-B on Order plan numbered 2024/014/PPO386/A4 TO AN ALTERNATIVE ROUTE in the parish of Crowland to be 2 metres wide running from Crowland Public Footpath No.6 at OSGR TF 2104 1231 (A) in a generally north north westerly direction for approximately 16m to OSGR TF 2103 1232 (C) then continuing west south westerly direction for approximately 207m to OSGR TF 2084 1225 (D) then running in a generally south south easterly direction for approximately 37m to terminate at an unaffected part of Crowland Public Footpath No. 6 at OSGR TF 2085 1222 (B). The total length of footpath added is approximately 260m as shown between points A-C-D-B on Order plan numbered 2024/014/PPO386/A4

PUBLIC PATH DIVERSION ORDER 2024

This Order is made by Lincolnshire County Council (“the Authority”) under Section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the Authority that in the interests of the owners of the land crossed by the footpath described in paragraph 1 of this Order, and the general public, that it is expedient that the line of the path should be diverted. South Holland District Council has been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situate at Crowland and shown by a bold continuous line on the drawing contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
2. There shall at the end of 28 days from the date of confirmation of this Order be a public footpath over the land situate at Crowland described in Part 2 of the Schedule and shown by a bold broken line on the drawing contained in this Order.

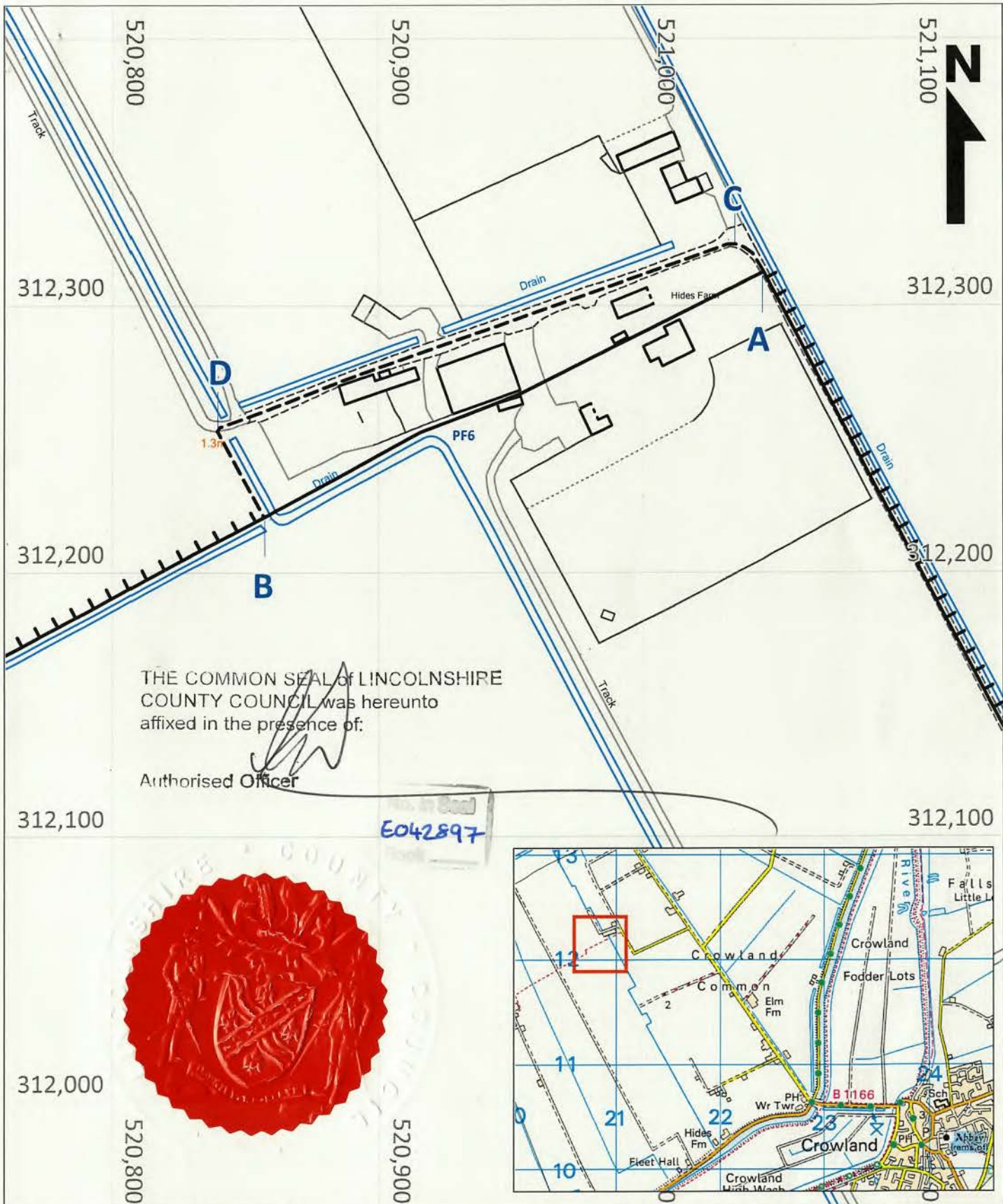
The whole width of Public Footpath No.6 running from Crowland Public Footpath No.6 at OSGR TF 2104 1231 (A) in a generally west south westerly direction for approximately 209m to terminate at an unaffected part of Crowland Public Footpath No. 6 at OSGR TF 2085 1222 (B). The total length of footpath diverted is approximately 209m as shown between points A-B on annexed plan numbered 2024/014/PPO386/A4.

Description of site of new path/ way

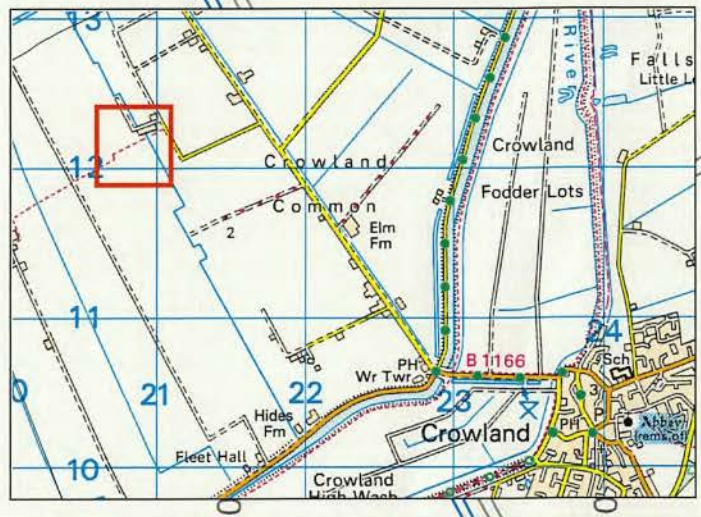
In the Parish of Crowland

A 2m wide Public Footpath running from Crowland Public Footpath No.6 at OSGR TF 2104 1231 (A) in a generally north north westerly direction for approximately 16m to OSGR TF 2103 1232 (C) then continuing west south westerly direction for approximately 207m to OSGR TF 2084 1225 (D) then running in a generally south south easterly direction for approximately 37m to terminate at an unaffected part of Crowland Public Footpath No. 6 at OSGR TF 2085 1222 (B). The total length of footpath added is approximately 260m as shown between points A-C-D-B on annexed plan numbered 2024/014/PPO386/A4.


