





- Footpath at SK 9248 6324 proceeding outwards along edge of arable field for approx. 170m before turning south west to bridge over River Witham at SK a stile into the It then goes south across a grass paddock over churchyard which is the ownership boundary. 9279 6294.
- Bridleway at SK 9314 6300 which enters ownership and after approx. 70m eaves ownership after running along riverbank in a westerly direction. 2
